On this day this matter came on for hearing and the County Court in session pursuant to ORS 368.570 and ORS 368.580 did consider the matter of the vacation of that portion of County Road #86 known as Wheeler Road, Original Road #389, as the same appears on the attached drawing marked Exhibit #1.

FINDING OF FACT:

The County Court finds that the said County road is not needed as a part of the County Road System, and has not been used as a part of said County Road System for many years. And that this portion of the Wheeler Road is a completely isolated part of the County Road System.

The County Court further finds that no person or persons residing on the County Road and depending thereon for access will be adversely affected by it's closure, and no adverse comment was made during the hearing of June 18, 1980 set by the County Court.

ORDER:


IT IS HEREBY ORDERED that the portion of the Wheeler Road #86, Original Road No. 389:

be VACATED pursuant to the map attached hereto and marked Exhibit #1.

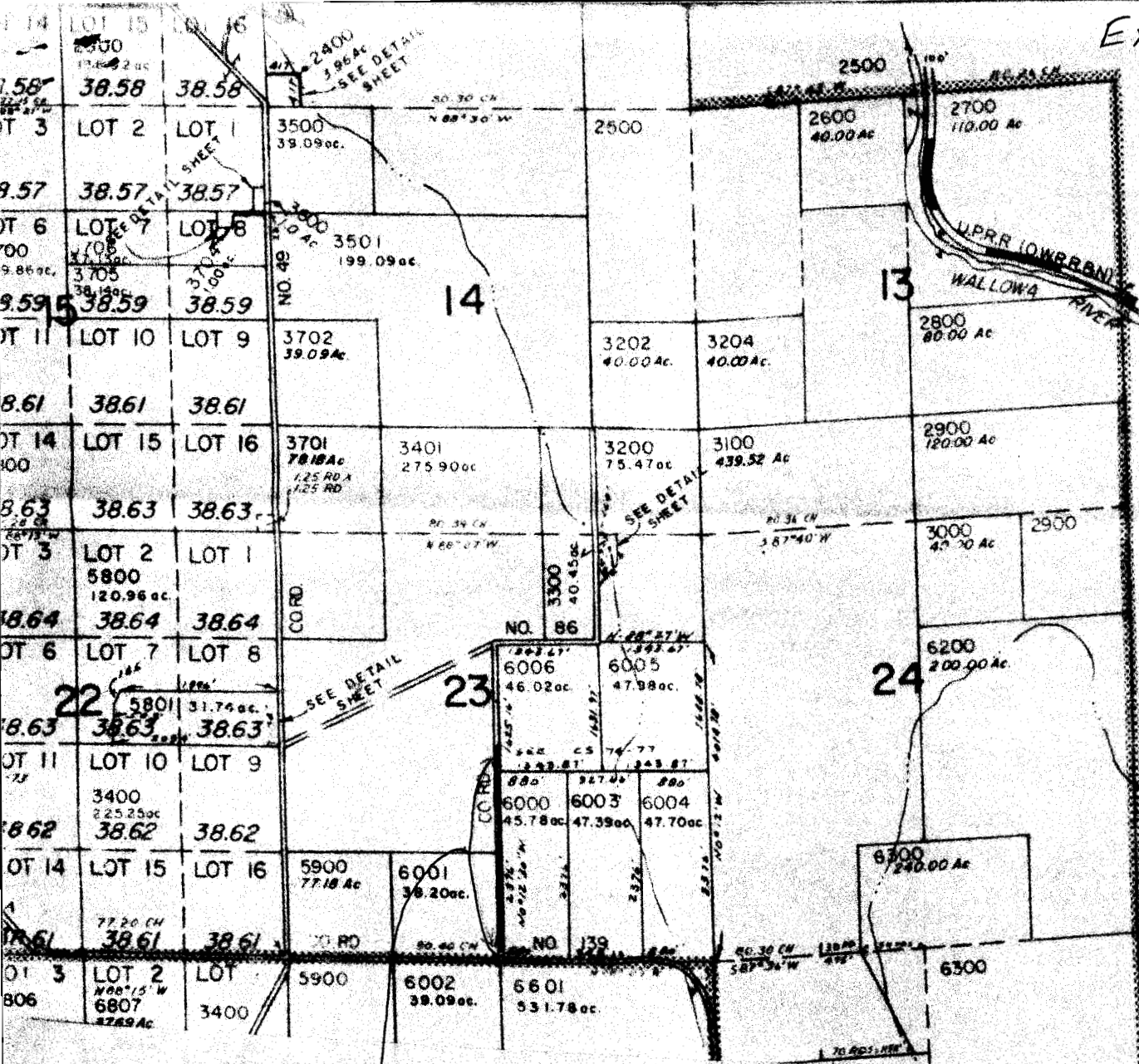

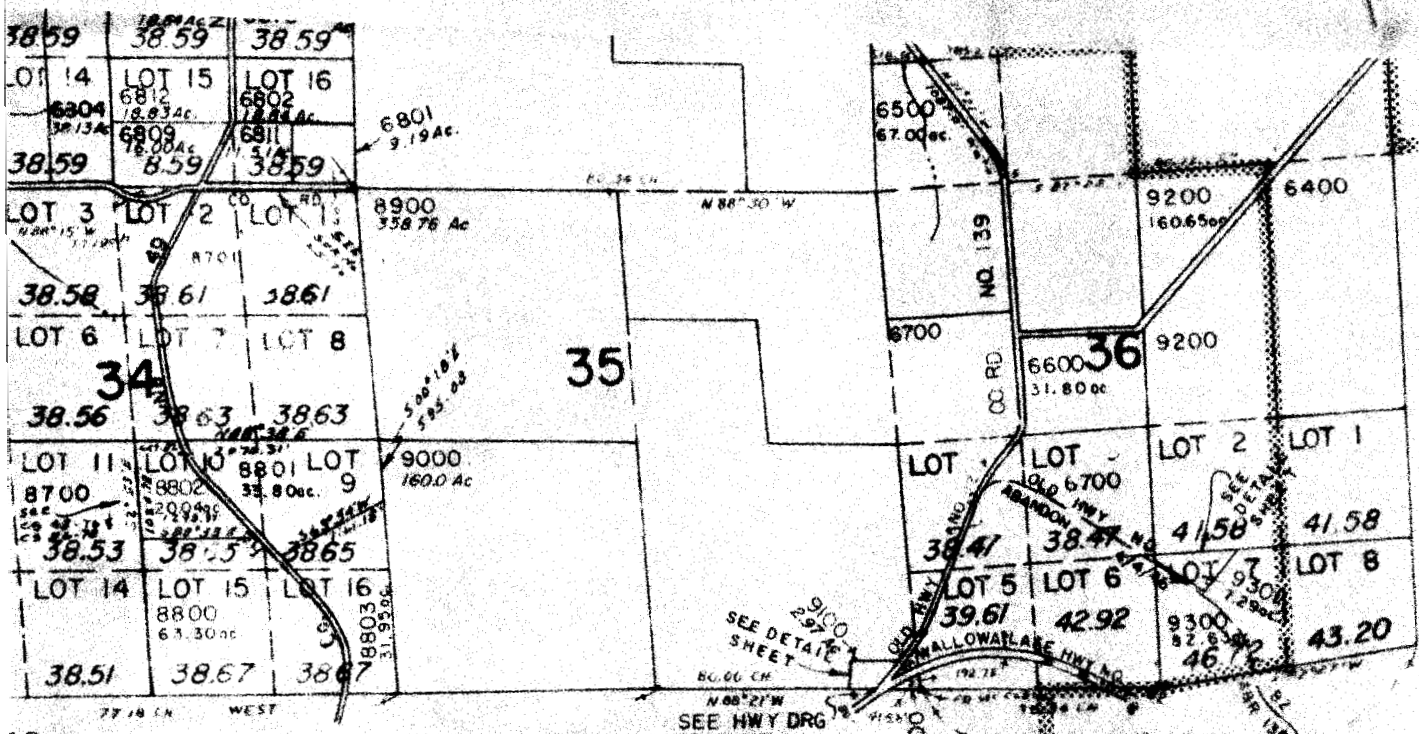
