WHEREAS, the Union County Public Works Department received Oregon Transportation Initiative Act (OTIA) funding to replace the bridge over Catherine Creek on Badger Flat Road between Medical Springs Highway (Oregon Highway 203) and the east line of the west half of the northwest quarter of Section 12, Twp. 5S, Range 40 EWM;

WHEREAS, Union County records do not include accurate survey information concerning the Badger Flat Road location between Medical Springs Highway (Oregon Highway 203) and the east line of the west half of the northwest quarter of Section 12, Twp. 5S, Range 40 EWM;

WHEREAS, Union County contracted with Anderson, Perry & Associates, Inc. to conduct a survey of Badger Flat Road between Medical Springs Highway (Oregon Highway 203) and the east line of the west half of the northwest quarter of Section 12, Twp. 5S, Range 40 EWM and file the survey with the Union County Surveyor;

WHEREAS, through omission or defect, doubt exists as to the legal establishment or evidence of establishment of Badger Flat Road from Medical Springs Highway (Oregon Highway 203) to the east line of the west half of the northwest quarter of Section 12, Twp. 5S, Range 40 EWM as a public road;

WHEREAS, the Union County Surveyor, Greg Blackman, has reviewed and approved Map of Survey for the Badger Flat Road legalization and recorded as 43-2002; and

WHEREAS, the Board of Commissioners proceeding under ORS 368.201 - 368.221 advertised and held a public hearing on December 4, 2002, to accept public testimony, deliberate and make a decision.


