WHEREAS, Union County received a petition from Gilbert Weatherspoon to vacate the following segment of Good Road: A 40 foot wide right-of-way 20 feet on both sides of the following described line: Starting at the SW corner of the NW  $\frac{1}{4}$  of the NE  $\frac{1}{4}$  of Section 32, Twp. 2N, Range 40 EWM, thence easterly about 1320 feet to the SE corner of the NW  $\frac{1}{4}$  of the NE  $\frac{1}{4}$ , thence northerly about 1320 feet along the east line of the NW  $\frac{1}{4}$  of the NE  $\frac{1}{4}$  of Section 32 to the NE corner of the NW  $\frac{1}{4}$  of the NE  $\frac{1}{4}$  of Section 32, thence easterly about 250 feet along the north line of the NE  $\frac{1}{4}$  of the NE  $\frac{1}{4}$  of Section 32 to the westerly right-of-way of Good Road. Excepting all of Good Road right-of-way as now may exist;

WHEREAS, the Board of Commissioners advertised and held a public hearing on May 17, 2006 to accept testimony, deliberate and potentially make a decision.


NOW THEREFORE, BE IT ORDAINED BY THE UNION COUNTY BOARD OF COMMISSIONERS, STATE OF OREGON:


SECTION 1: ROAD VACATION

The following road segment is vacated to adjacent landowners per ORS 368.366(1)(d):

A 40 foot wide right-of-way 20 feet on both sides of the following described line: Starting at the SW corner of the NW  $\frac{1}{4}$  of the NE  $\frac{1}{4}$  of Section 32, Twp. 2N, Range 40 EWM, thence easterly about 1320 feet to the SE corner of the NW  $\frac{1}{4}$  of the NE  $\frac{1}{4}$ , thence northerly about 1320 feet along the east line of the NW  $\frac{1}{4}$  of the NE  $\frac{1}{4}$  of Section 32 to the NE corner of the NW  $\frac{1}{4}$  of the NE  $\frac{1}{4}$  of Section 32, thence easterly about 250 feet along the north line of the NE  $\frac{1}{4}$  of the NE  $\frac{1}{4}$  of Section 32 to the westerly right-of-way of Good Road. Excepting all of Good Road right-of-way as now may exist.
