WHEREAS, ORS 373.270 states that jurisdiction over a county road within a city may be transferred whenever the county governing body deems it necessary, expedient or for the best interest of the county to surrender jurisdiction over any county road or portion thereof within the corporate limits of any city and the governing body of the city deems it necessary or expedient and for the best interests of the city to acquire jurisdiction over the county road or part thereof to the same extent as it has over other public streets and alleys of the city;

WHEREAS, the following county road segment is proposed to be transferred: any part of East Street in County Road jurisdiction beginning at its intersection with Oregon Highway 237 extending south to 5th Street;

WHEREAS, the County Board of Commissioners advertised and held a public hearing in accordance to ORS 373.270(2)(b) and accepted public testimony on the proposed jurisdiction transfer.

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE COUNTY OF UNION, STATE OF OREGON:

SECTION 1: SURRENDER OF JURISDICTION OFFER

The jurisdiction of the following county road segment is offered to the City of Island City (see attached Exhibit A & Exhibit B): Any part of East Street in County Road jurisdiction beginning at its intersection with Oregon Highway 237 extending south to 5th Street inside the Island City city limits.


SECTION 2: TIME LIMIT OF ACCEPTANCE

The Union County Board of Commissioners allows the City of Island City six months to accept the offered street segment. This offer will expire at the end of that time period if not acted on.

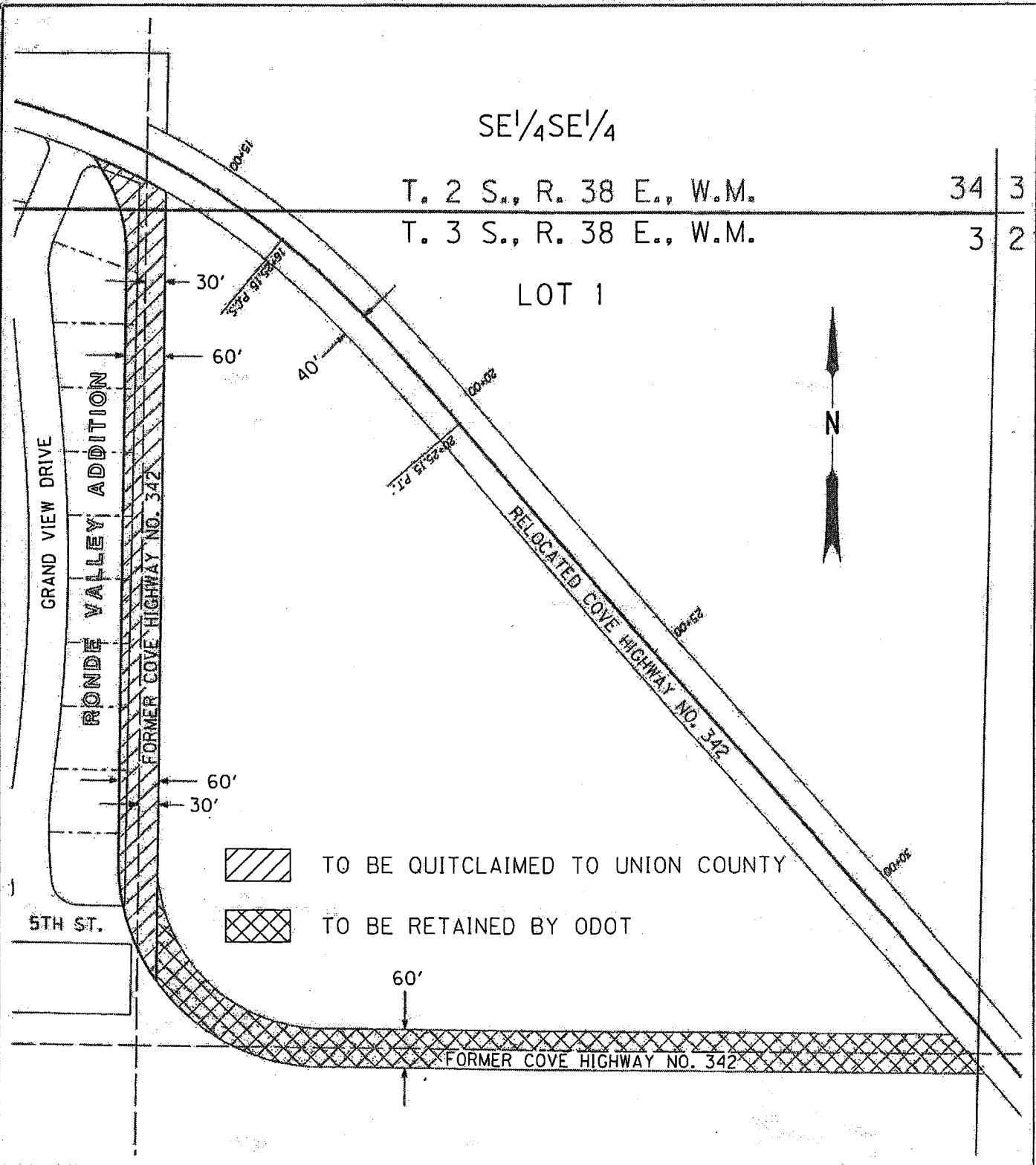

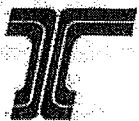
