The purpose of this report is to review for the new commissioner as well as the other two members what has transpired in the past concerning the Mucurdy or Tamarack Springs road listed by the the County as Road No. 147.

In 1971, I approached the Judge about making 3/4 mile of private road a County road because of the large number of people using the road. He advised it could be made a County road through public use and suggested that a petition be presented to the court listing use#s of the road. At the same time the Judge advised that the County needed rock for crushing fo use in the Northwest corner of the valley and that the crushed rock would be needed before the County could do improvement work on the road. I advised him that there was a good quality rock available on the MuCurdy place. Eventually, I showed the Road Master and his assistant where the rock was located. Test Holes were made. After a period of negotiations with Mrs. McCurdy and hearings before the Union County Planning Commission, the gravel pit was approved on June 26, 1972 and the record shows that the Judge reported that the access road is a County road, though all of it hasn't been formally dedicated. Before the planning Commission approved the pit, a representative of the commission contacted me and had me show him where the rock was located in relation to the McCurdy road. The approach made by the Court to the Planning Commission was that the pit was needed to have crushed and fill rock available for the McCurdy road and roads in the general area. I appeared at two hearings in support of establishing the gravel pit. The Judge and the road Commissioner also appeared in support and explained the need for crushed rock in the area. Prior to this on April 5, 1972, the entire Court, with the Roadmaster made an inspection trip to the Mc-Curdy gravel site. A Contract was agreed upon in October 1972 by the Court and Mrs. McCurdy and filed in the County Clerks office December 27, 1972.

A petition, as requested by the Judge, listing over 300 users of the road was presented to the Court, August 4, 1971, and after a brief period, I was advised by the Judge and the Road Commissioner that the Court has declared the road to be a county road through public use. This is confirmed by the fact that on November 2, 1972, the County Court agreed unanimously to accept and place the McCurdy or Tamarack Springs road into the county road system. The decision was based on (10. Public use of the road for a period of 10 years; and (2). County has done maintenance on the road for over a period of the required 10 years. On November 21, 1972 the road was assigned road No. 147. In meetings I have had with the court designated the road to be a County road because of public use.

I appeared before the Court in 1972 at budget time to be sure money was in the budget for rebuilding the road. I was assured by the Judge and other members of the court that the necessary funds were budgeted for the fiscal year 1972-1973. This is supported by the fact that a work order dated May 12, 1972 was made out to start construction. In 1971 a priority was set for the construction of the Mc Curdy or Tamarack Springs Road during the 1972-73 fiscal year. Construction had not taken place by budget time in 1973 so I appeared before the Court again to be sure the funds were rebudgeted and again was assured sufficient funds were still available for the 1974-75 fiscal year.

In December 1972 and January 1973, the gravel pit was opened up and 20,000 yards of rock was crushed. In the summer of 1973, the County hauled about 19,000 yards of crushed rock over the road. Up to this time no improvement work, except for some maintenance had been done on the road but snow removal was performed. After a week of hauling crushed rock, the road was so rough on the trucks, the suface was graded and crushed roack applied. Since it was planned to rebuild the road, only a minimum amount of crushed rock was applied. The principle reason for helping the county get the gravel pit, which is located 1/4 mile west of the upper end of the Tamarack Springs road, was to have the crushed rock for the 3/mile of road and regravel the roads in the general area. Except for what was put on the 3/4 mile, only a few yards were used at three locations in the immediate area, totaling about 2000 feet. At the present time, there is about 900 yards remaining, but based on the contract with Mrs. McCurdy, plenty of rock for filling and crushing is available.

Negotiations for securing the right-of-way did not take place until 1972. On December 15, 1972, we signed a QuitClaim Deed turning over 30 feet off the north end of our prop in the presence of Commissioners Schaad and Elmer, with the understanding the 30 feet would be from the center of the present road, since we had already provided 20 feet for the private road. On December 27, 1972 the Road Commissioner returned to have a correction made on the deed. The County owned 30 feet off the McCurdy property which was deeded to the County when the property was owned by Herb Weiden. On the Maloy property, to the east of me, the Court has a letter from Mr. Maloy stating that when the County is ready to build the road, he will deed 30 feet from the center of the present road. The first 3/4 mile of the present road on the east end consists of a 40 Foot strip listed in the Doty deed as an easement for a 40 foot private roadway. This roadway was set up by Harold Transue when he owned the peoperty for the benefit of Elmer Varner and Martin Weir who were living above. Weir who were living above. Weir and Maloy owned the property now owned by Robert Maloy. The court has established and has a record that the court acquired 33 feet for a roadway in 1936 off the south end of the property now owned by =oe Scott, through nonpayment of taxes. The County Surveyor has established the lines from two established markers and has shown that the 33 feet the County owns is not part of the present 40 foot roadway. The surveyor has also developed a construction drawing showing where the center of the road will be and both sides. The Court completed negotiations with Mr. Doty for the land in the present 40 foot easement, but I understand the Court has not paid him the cmount agreed upon. This completes the roadway for a 60 foot width and all that is left is for the court to exercise the authority that they have to rebuild this road.

(Read Observer Article)

On February 7, 1974, The Court agreed to view on the site the Tamarack Springs road and set up guide lines. The Judge called a hearing for July 3, 1974. The Judge stated in his letter, "The purpose of the hearing is to discuss in more detail exactly how the County intends to lay out the road and what the County will do as it concerns fences, relocating fences, culverts etc." Another hearing was held November 6, 1974. At both of these meetings the Judge reported that the road had been made a County roadthrough public use.

At the November meeting the Judge asked Mr. Doty if he was willing to proceed with the a greement that had been reached and Mr. Doty acknowledged in the meeting that he would fulfill the agreement. Although a drawing of the proposed roadway was presented, the hearings centered around where the right-of-way boundary should be.

The road leading to Smith Canyon was established in the 1920's and the first 3/4 mile which consists of the 40 foot easement was graded in 1943. In 1952, Mr. Cy Morgan, County Engineer, established the lines for extending the roadway an additional 1/2 mile west and established the lines between my property and that of Sylvan Hewitt, Elmer Varner, Weir and Maloy, and Starns Brothers. When this was done all accepted the lines and the lines are still in existence. In the summer of 1953 the land owners using the road, consisting of Hewitt, Varner Weir and myself, paid the County, each an equal amount, to grade the West 1/2 mile. We then rocked the lower 1/2 mile and all shared equally in the cost. The upper 1/4 mile was rocked by Herb Weiden when he purchased the Hewitt property and I paid 1/2 of the rocking charge which was done by the Union County Soil Conservation District. The present location was a public use road for 19 years until November 2, 1972 when the County took it over officially. For 22 years the present 3/4 mile of road has been in use and is used as a public road.

At the December 11 and 12, 1974 Court Meeting, the Court took action on a petition to discontinue improvement and maintenance on the road without giving reasons to the property owners for doing so. (motion to advise owners.) There were 129 signers on the petition and only two were involved in the road and they consisted of only one property owner who had agreen to accept the agreement reached between him and the court.

At various times during the past 22 years, logs have moved over this road to Peacock Lumber Co., S & G. Lumber Co., and Boise Cascade. In 1973 the County hauled 19,000 yards of crushed rock in 10 and 20 yard trucks. This represents 950 = 20 yard loads weighing 57,000 pounds per load. In 1974, 150 loads of logs came out over this road. In 1975 over two million board feet of B.L.M. timber will move over the road and this represents 460 to 470 loads of 4500 board feet per load. In addition there will be trucks moving in and equipment and loggers moving in and out. THE ROAD WAS NOT CONSTRUCTED FOR THIS KIND OF TRAFFIC. In addition, hundreds of people and cars from all over the county and outside the county travel this road every year. I acknowledge that the road ends in a distance of 3/4 mile and the remainder of the road is private but it does serve seven land owners, considerable private and Federal timber land, and the county gravel pit. The county has constructed many roads in the mountain area of the county, that you might say go nowhere and in many cases have built school bus turn arounds. While there are many more, I have a list of 18 of these established roads all of which the County has built into first class roads. These run from 3/4 mile long to 2 and 3 miles long. No t one of these roads have the traffic that moves annually over the McCurdy or Tamarack Springs Road.

It is quite possible the area served by this road generates more county tax money than any one of the 18 roads I have listed. The county shares in the timber tax from the U.S. Forest Service and private timber and receives a share of the PUC truck taxes, gas and license fees. In addition, the property owners involved hav paid substantial property and personal property taxes on the same basis as other property owners in the county.

While we, as property owners, are satisfeied with the present width of the right-of-way, it was the county who decided they wanted a 60 foot right-of-way to aid in snow removal. The 40 foot width was established by the County Engineer in 1952 as it met the width requirements of the State of Oregon for county roads. The Oregon Statute 368.415 covering county roads established after August 2, 1951 and amended in 1953 and 1971 points out in Section 3 that, "The County Court may by resolution adopt standards for county roads less than 50 feet in width. Such standards may include amon other things, width, length, design and construction, limitations on access and restrictions on on-street parking." Section 2 states, "After Acceptance the county shall maintain such highway, road or street as a county road." If the present 40 foot roadway is properly built, up and snow fences used it will help the snow problem considerably. During the month just past, the snow conditions have shown that it made no difference whether there was a 40 foot or a 60 foot right-of-way.

An accurate estimate of \$14,304 has been made on the cost of improving the present road to a 28 foot road surface with an average of 2 feet of base rock and 4 inches of crushed rock. The estimated construction time is two weeks. If a 60 foot right-of-way is used the road surface would be 32 feet, only four feet more than for the present road. The increased cost will be about 40% or about \$20,000,plus the cost of culverts, fences and right-of-way. If the lower 1/4 mile is raised 3 feet with base rock and the upper 1/2 mile with 1 1/2 feet of base rock and snow fence used, the snow problem will be no worse than on other roads in the area.

I suggest that letters that may have been received by the court supporting the improvement of this road be read and be included in the records of this meeting.

In addition to the statements presented today we are submitting to the court a new petition listing 333 names of people who are requesting that construction get underway as soon as weather permits in the Spring. We have been very selective in securing names. Many represent firms and businesses who have a direct interest in the road. Others use the road several times a year. The original copy of the petition is being presented to the Judge and copies to the other two members of the court and the county clerk, so if the petition is misplaced there will be copies available. You will also note that the pages are numbered stating the number of pages represented by this petition.

The Court is urged to take action today on the following points:

1. If not already done, rescind the motion made and passed at the December 11 and 12, 1974 meeting to accept the petition presented and discontinue improvements and maintance work on the road.

2. Pass a new motion reaffirming the courts November 2, 1972 decision to make the McCurdy or Tamarack Springs road a county road through public use.

- 3. Agreed with County Court to eliminate 2-5-75 signed J.W. Jarvis.
- 4. Since the court has a complete record of all conversations and business conducted in County Court meeting, it is requested that references, discussions and hearings pretaining to this road since 1971 be assembled into one report for ready reference.
- 5. I also request that this report and the petition dated February 5, 1975 be made a part of the minutes of this meeting and copies be placed on file in the Judges offices and in the County Clerk's office. In addition, the statements presented by others present, written or oral, and letters recieved by included. Further, since this meeting is being taped, it is requested that the tape be transcribed and a typewritten copy be placed in the files as a matter of record where it is readily available.
