THIS INDENTURE, WITNESSETH, That S.J. Lile
and Nora Lile his wife, for the consideration of One DOLLARS,

to them paid, has bargained and sold, and by these presents do bargain, sell and convey unto the County of Union, State of Oregon, the following described land for road purposes, to-wit:
All that part of the property in the NE 1/4 of the SE 1/4 of Section 20, T 6, S.R. 41, E.W.M., within a strip of land 60 feet in width being 30 feet on each side of the center line of the Telecaset-Medical Springs Market Road, as surveyed over^{and}/staked across said property, said center line being more particularly described as follows:

Beginning at a point approximately 1355.0 ft north and 400.0 ft. west of the section corner common to Sections 20, 21, 28 and 29, T 6 S.R. 41 E.W.M; Union County State of Oregon; thence N. 79 degrees 25 minutes E. 407.0 feet, more or less, to a point on the east boundary of said property, said point being approximately 1430.0 ft.
