THIS INDENTURE, WITNESSETH, That C. H. Arnoldus and Stena Arnoldus,  
and his wife, for the consideration of

One and no/100 DOLLARS,

to them paid, have bargained and sold, and by these presents do bargain, sell and convey unto the County of Union, State of Oregon, the following described land for road purposes, to-wit:

**All that part of the property outside of the land already dedicated to the public use or otherwise as a county road, necessary to encompass a strip of land 30 feet wide, adjacent and parallel to, and on the right side of the center line of the Hunter Lane-Pleasant Grove Market Road as surveyed over and across the SE quarter of the SW 1/4 and the SW 1/4 of the SE 1/4 of Section 15 T 1 SR 38 NWM, being more particularly described as follows:**

Beginning at a point designated as Station 584/32.6 said station being approximately 31.5 ft. North and 2398.3 ft. East of the Section corner common to sections 15, 16, 21, and 22, Tp 1 SR 38 NWM, thence N 13° 56' E a distance of 604.5 ft., thence on a 2865.0 ft radius curve to the left a distance of 696.7 ft. thence north a distance of 52.8 ft. to station 598/35.0, said station being approximately 1360.9 ft. North and 2628.2 ft. East of the Section common to sections 15, 16, 21, and 22 Tp 1 SR 38 NWM.

This parcel of land contains 0.11 acres more or less.
