to them paid, have bargained and sold, and by these presents do bargain, sell and convey unto the County of Union, State of Oregon, the following described land for road purposes, to-wit:

All that part of the property not already dedicated to public use as a County Road located in the NE 1/4 of the NE 1/4 of Section 29 and the SE 1/4 of the SE 1/4 of Section 20 T 5 S, R 39 EWM, encompassed in a strip of land 60 feet in width being 30 feet on each side of the center line of the North Powder-Clover Creek Market Road as surveyed over and across said property and being more particularly described as follows:

Beginning at station 299/52.0 which station is approximately 1320.0 feet South and 829.2 feet West of the section corner common to sections 20, 21, 28 & 29 T 5 S, R 39 EWM, thence N 10° 07' W a distance of 2393.0 feet to station 323/45.0 which station is approximately 1038.0 feet North and 1320.0 feet West of the section corner common to sections 20, 21, 28 & 29 T 5 S, R 39 EWM.
