

to her paid, has bargained and sold, and by these presents does bargain, sell and convey unto the County of Union, State of Oregon, the following described land for road purposes, to-wit:

All that part of the property located in the SE 1/4 of SE 1/4 of Section 29 T 2 N R 40 EWM within a strip of land 60 ft in width being 30 ft on each side of the center line of the Cemetery-Cricket Flat Market Road, said tract of land being more particularly described as follows:

Beginning at a point designated as station 113/93.0 said station being the intersection of said center line with the north fence line of the present County Road and approximately 29 ft north and 932.0 ft west of the section corner common to sections 28, 29, 32 & 33 T 2 N R 40 EWM, thence on a 955.0 ft. radius curve to the right a distance of 80.2 feet, thence N 52° 15' E a distance of 883.6 ft, thence on a 477.5 ft radius curve to the left a distance of 259.2 ft to station 126/16 said station being the intersection of said center line with the west fence line of the present County Road and approximately 828.5 ft north and 27.0 feet west of the section corner common to sections 28, 29, 32 & 33 T 2 N R 40 EWM said tract of land contains 1.68 acres more or less.

TO HAVE AND TO HOLD the said land, with its appurtenances, for county road purposes to said Union County and the public therein forever, and
