THIS INDENTURE, made this 2 day of July, 1929, between Jesse Breshears as Sheriff of Union County, State of Oregon, the party of the first part, and Union County, Oregon, party of the second part.

WITNESSETH, that whereas, at a public sale of real estate held on the 8th day of June 1929 A.D. pursuant to a real estate tax judgment and decree of the Circuit Court of the State of Oregon for the County of Union duly made and entered on the 23rd day of May, 1929 and after having first given due notice of the time and place of said sale; and
