THIS INDENTURE, WITNESSETH, That James Goble and ~~Estella Goble~~
and Estella Goble his wife, for the consideration of

One DOLLARS,
to us paid, has bargained and sold, and by these presents do bargain, sell and convey

unto the County of Union, State of Oregon, the following described land for road purposes, to-wit:
A strip of land 60 feet in width, being 30 feet on each side of the center line of the Union-Medical Springs Market Road, from Survey Station 993/37.7 to Survey Station 1023/09.0, said center line being more particularly described as follows: Beginning at a point West 1142.0 feet from the NE corner of the NW $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 24 Tp 6S R41 E11W, and running thence to the left on a 573.0 feet radius curve a distance of 135.0 feet; thence S 46° 30' E a distance of 383.8 feet; thence to the right on a 955.0 feet radius curve a distance of 565.3 feet; thence S 21° 35' E a distance of 69.3 feet; thence to the left on a 1432.5 feet radius curve a distance of 397.9 feet; thence S 28° 30' E a distance of 747.7 feet to a point north 650.0 feet from the SE corner of the SW $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Section 24 Tp 6S R41 E11W. Said strip of land contains 3.17 acres more or less. The above description includes .48 acres which is contained in the present County Road No. 238.

TO HAVE AND TO HOLD the said land, with its appurtenances, for county road purposes to said Union County and the public therein forever, and James Goble and Estella Goble do hereby covenant to and with the said Union County that they are the owners in fee simple of said lands; that they are free from all encumbrances except x - x
