THIS INDENTURE, WITNESSETH, That Eldon A Rush

and Edna Rush his wife, for the consideration of

One dollar and other valuable considerations --DOLLARS,

to US paid, have bargained and sold, and by these presents do bargain, sell and convey unto the County of Union, State of Oregon, the following described land for road purposes, to-wit:

All that part of the property of Eldon A and Edna Rush located in the NW 1/4 of the SW 1/4 and the SW 1/4 of the NW 1/4 of Sec. 4 T 1 N R 39 E, WM contained in a strip of land 30 ft in width being 30 ft on the right side of the center line from station 99+50.0 to station 117+37.4 as surveyed over and across said property, and being more particularly described as follows:

Beginning at station 99,50.0, said station being approximately 2206.5 ft. north and 10.8 ft. east of the section corner common to sections 4, 5, 8 and 9, T 1 N R 39 E, WM, thence on a 477.5 ft radius curve to the left a distance of 39.5 ft., thence N 0°27' West a distance of 394.7 ft., thence N 2°37' East a distance of 1353.2 ft., to station 117+37.4 said station being approximately 1401.4 ft. south and 89.8 ft. west of the section corner common to sections 4, 5, 32 and 33, T 1 N R 39 E, WM, and T 2 N R 39 E, WM.

Said parcel of land contains 0.31 acres, more or less, excluding land already dedicated to public use.

TO HAVE AND TO HOLD the said land, with its appurtenances, for county road purposes to said Union County and the public therein forever, and we the said Eldon A. Rush and Edna Rush, his wife do hereby covenant to and with the said Union County that we are the owner(s) in fee simple of said lands; that they are free from all encumbrances except
