THIS INDENTURE, WITNESSETH, That David Scott

and Estella Scott, his Wife his wife, for the consideration of

One Dollar (\$1.00) DOLLARS,

to him paid, has bargained and sold, and by these presents do bargain, sell and convey unto

the County of Union, State of Oregon, the following described land for road purposes, to-wit:

All that part of the property of David Scott located in the NE 1/4 of the SW 1/4 of section 10 T 2 N R 40 EWM within a strip of land 60 ft. wide, being 30 ft. on each side of the center line as surveyed over and across said property, and being more particularly described as follows:

Beginning at station 304+68.0 said station being approximately 1321.8 ft. south and 2604.4 ft. East of the 1/4 section corner between sections 9 and 10 T 2 N R 40 EWM.; thence on a 358.1 ft. radius curve to the right (the long chord of which bears N33 20' W 134.8 ft.) a distance of 135.7 ft.; thence N22° 29' W a distance of 1418.0 ft. to station 318+86.0 said station being approximately 24.8 ft. south and 2037.4 ft. East of the 1/4 section corner between sections 9 and 10 T 2 N R 40 EWM.

Said tract of land contains 1.95 acres, more or less.

TO HAVE AND TO HOLD the said land, with its appurtenances, for county road purposes to said Union County and the public therein forever, and they the said David Scott and Estella Scott,

his wife do hereby covenant to and with the said Union County that they the owners in fee simple of said lands; that they are free from all encumbrances except No Exceptions.
