in consideration of One and No/100 - - - - - Dollars,

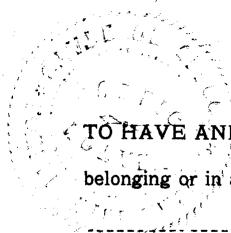
