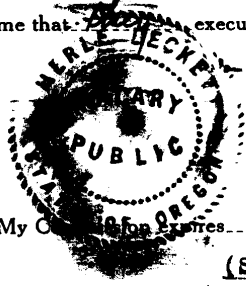

THIS INDENTURE, WITNESSETH, That

George W. Decker

and M. Anne Decker his wife, for the consideration of One (1) and no/100 DOLLARS,

to them paid, has bargained and sold, and by these presents do bargain, sell and convey unto private the County of Union, State of Oregon, the following described land for road purposes, to-wit:

A parcel of land lying in the East half of the Northeast quarter (NE 1/4) of Section 17, T.2 S. R. 38 E.W.M; Union County, Oregon, and being more particularly described as follows:

Beginning at the quarter corner between Sections 16 and 17, T 2 S R 38 E.W.M., thence West 1320 ft., thence North 16.5 ft., thence East 1320 ft., thence South 16.5 ft., to place of beginning. Containing 0.5 acres of land more or less.

Reserving to themselves the right to travel said road for the purpose of access to lands owned by them adjacent to said road.
