Sealed with our seal the 4th day of July,
A.D. 1868

The Conditions of the above obligation is
such that if the prayer of the petitioners for
a County Road hereto annexed be not
granted and allowed the above bounden
Benjⁿ Stanton and Samuel Hannah,
their heirs, executors, administrators or assigns
will pay or Cause to be paid to the County
of Union aforesaid, all cost and expenses
which may be incurred, by reason of the
view and survey of said road. — then this
obligation to be void, otherwise to remain
in full force and virtue

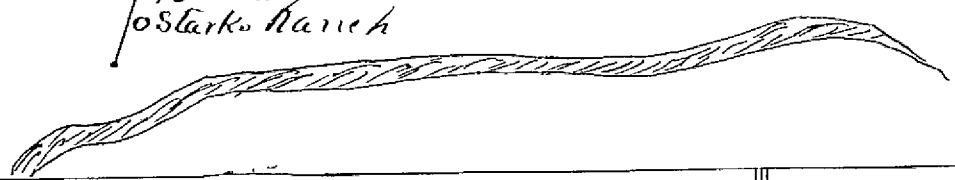
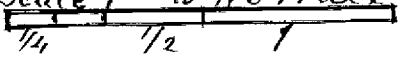

Now on this day was presented a petition by the Citizens of Union Precinct praying for the appointment of Viewers to view a proposed County road commencing at the town of Union in Said County and running in a southerly direction through Rylo Canyon to the nearest and most feasible point on Powder river and terminating at said point, which said petition being duly accompanied with a bond and notice said petition was granted and C. J. Wilson Saml. Bloom. S. T. McConag and Friday July 17th 1868 was set as the day for the meeting of said Viewers to meet at point of beginning and S. L. Curtis was appointed to survey the same

In the matter of a
Change in County fund
by Treasurer J. L. Morron

It appearing to the Court that J. L. Morron County Treas did at the commencement of his said term office charge himself debtor to the sum of One Hundred and fifty nine and six cents as County fund which sum properly belonged to the State fund and said fund being afterwards changed to its proper place leaving said Treasurer debtor to said sum of \$159.06 it is therefore ordered by the Court that J. L. Morron receive a Credit of said sum of \$159.⁰⁶
