In the Matter of the approp- }
riation on Road East of Elgin }

This Matter came on to be heard at this time on the petition of numerous citizens of Elgin asking for an appropriation of \$300 to assist in grading the County Road East of Elgin, And it appearing to the Court that said road is in a bad condition and that the same ought to be graded from the bridge East to the top of the hill and it appearing that Mr Cowan and across whose lands said road extends have consented to change their fences so as to throw said road on better ground and will be more easily graded and that the Court ought to make an appropriation to assist the people of Elgin in grading said road It is therefore considered and ordered that \$500 be appropriated out of the County Treasury to assist in improving and grading said road and that said appropriation be placed in the hands of John McDonald County Commissioner who may employ such proper person as he may see fit to have charge of said work
