Now on this day was read a first time the Report of the viewers appointed to view out a county Road beginning at a point where the LaGrande and Cox Road crosses the line between Section 14 and 15 T. 3 S. R. 39 E thence running in a northerly direction to intersect the Summerville & Shoemaker Point Road.

Road Viewers Report } Sept 8<sup>th</sup> 1875-

Now on this day was read a first time the Report of the Viewers of a proposed County Road commencing at the North East Corner of Sec 36 Town 3 S. R. 38 E thence due south to intersect the County road running from the Town of LaGrande to Union.

No further business appearing the Court adjourned until 9 O'clock to morrow morning

Road Viewers Report }<sup>s</sup>

Sept 9<sup>th</sup> 1875

Now on this day was read a second time in open court. The report of the Viewers appointed to view out a certain proposed County Road beginning at the North East corner of Sec 36 T3 S R 38 E. Thence due South to intersect the County Road leading from Sulgrave to Union: which report was accompanied by field notes of the Survey and view of said Road which are as follows. Beginning at a post marked R placed in the ground at the N.E. corner of S. 36 T3 S. R 38 E. Thence due South 120 chains to post marked R I and intersecting the County Road.
