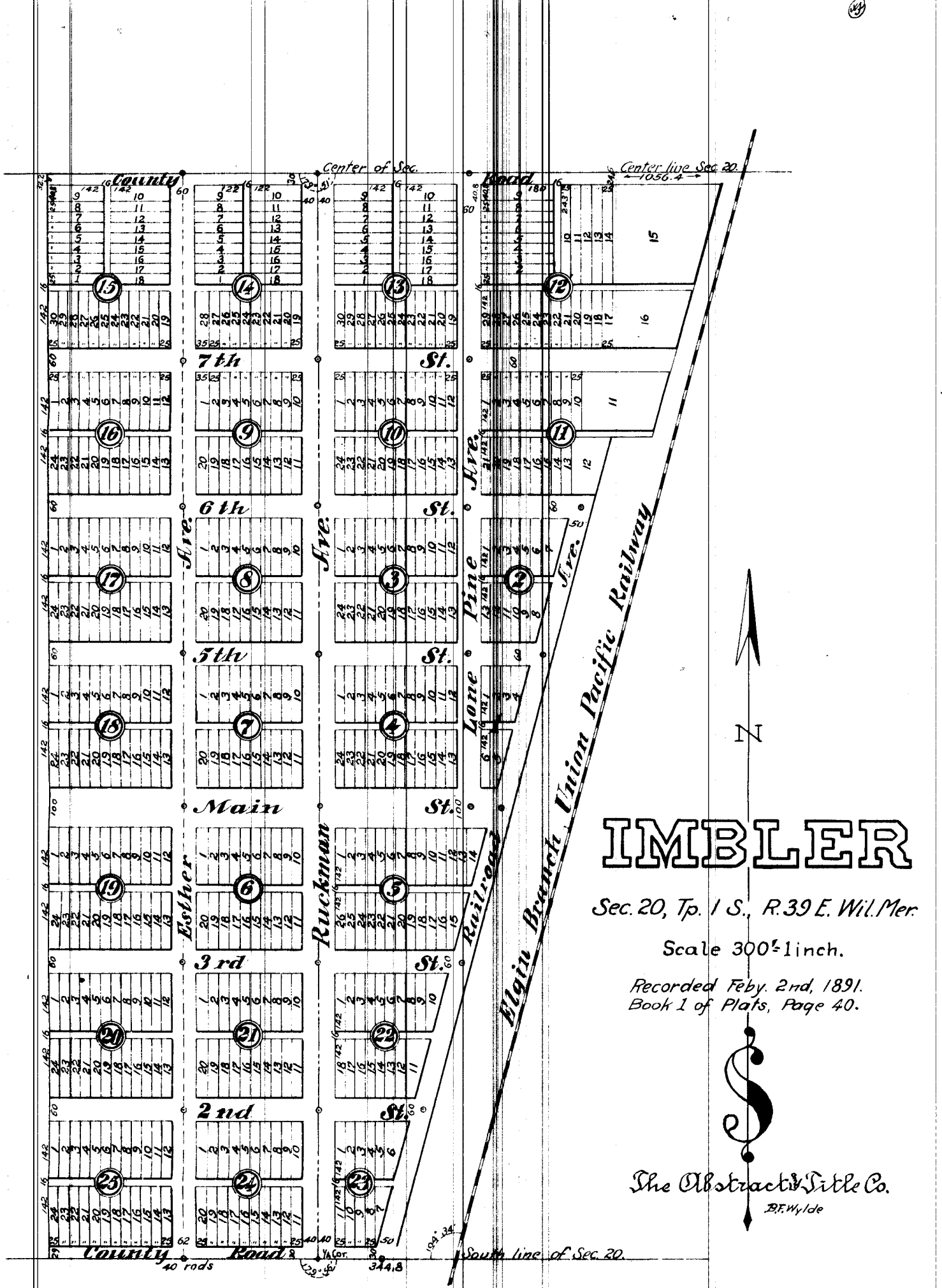

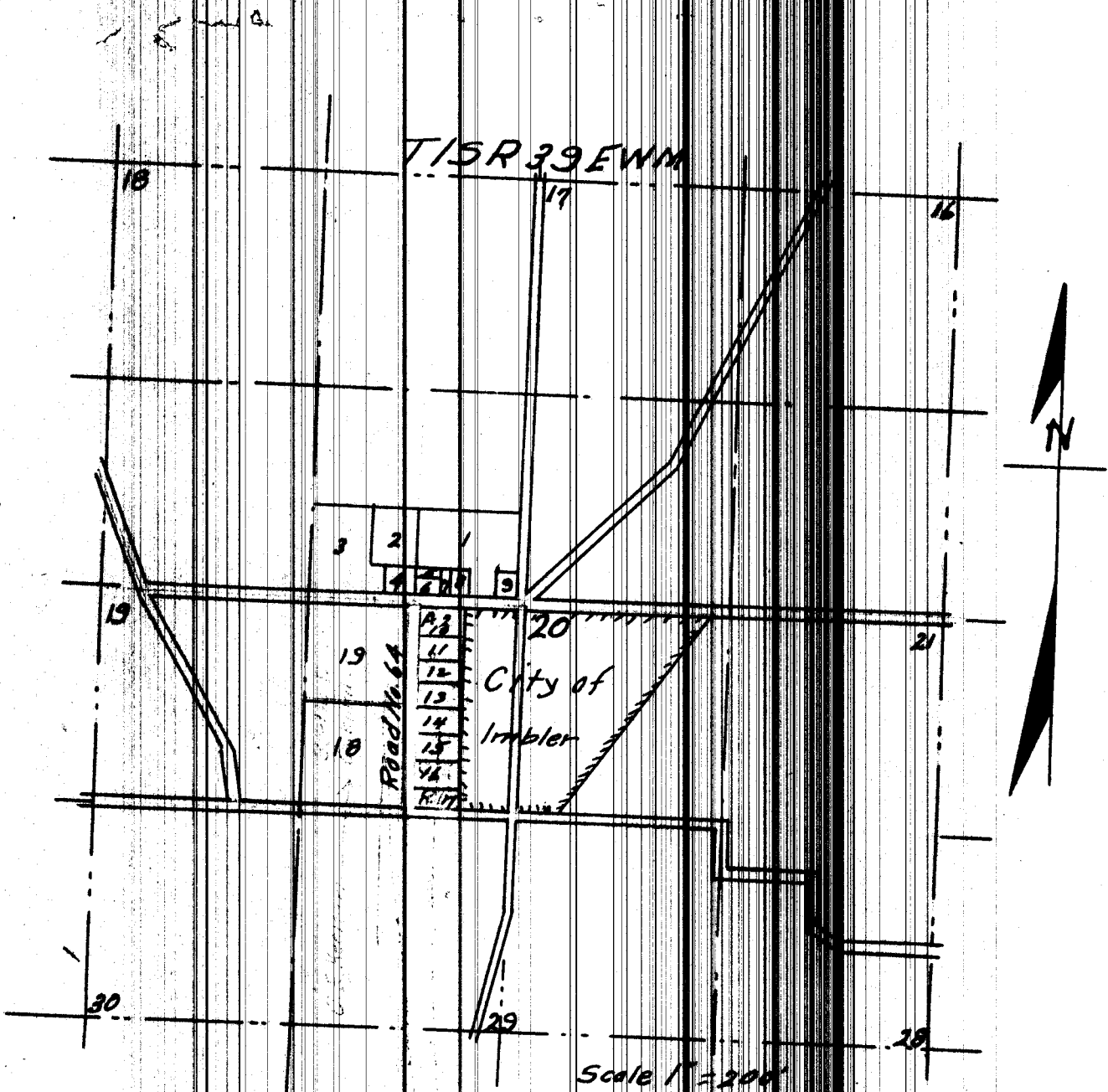
To The Honorable County Court of Union County, Oregon:


