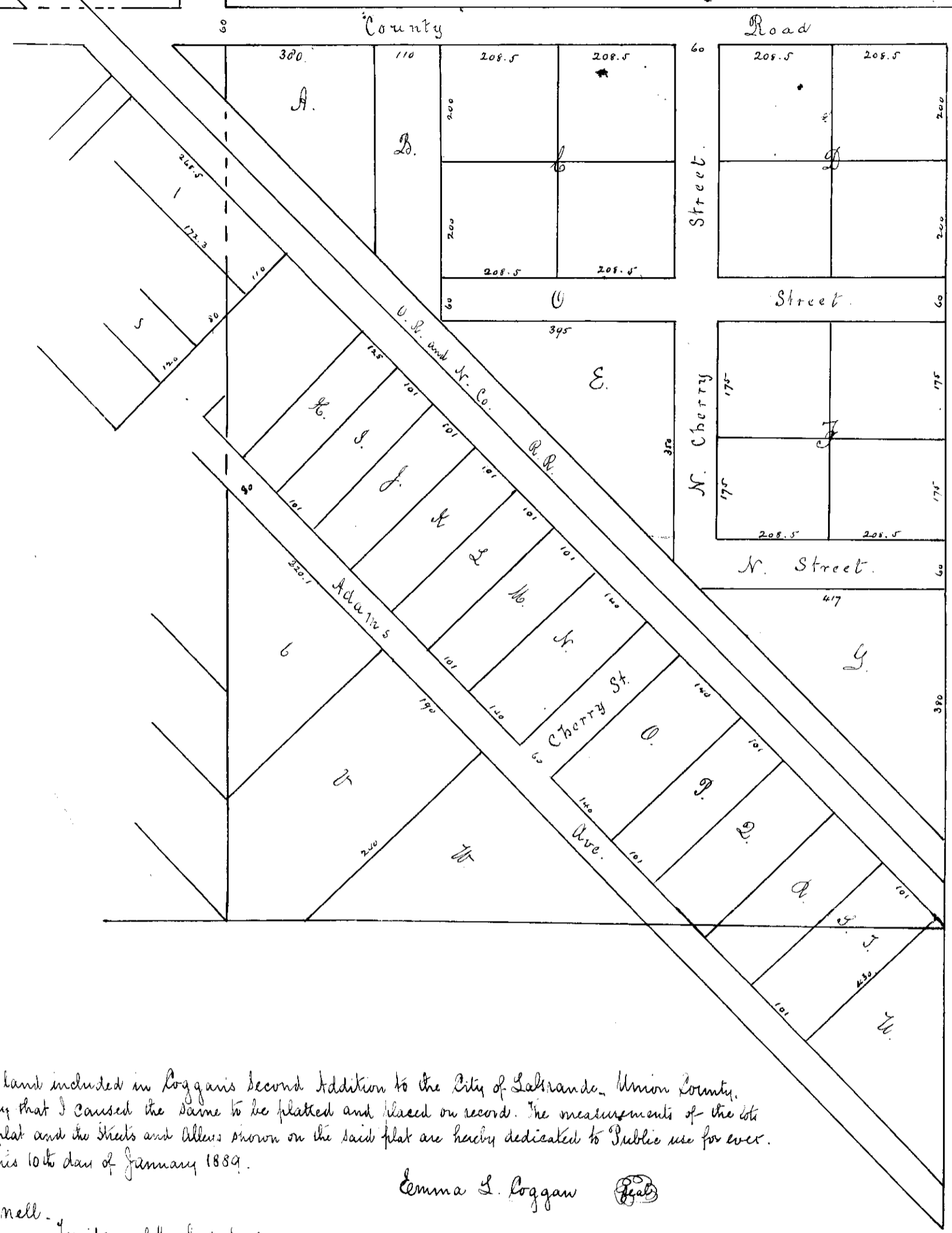


COGGAN'S SECOND ADDITION.

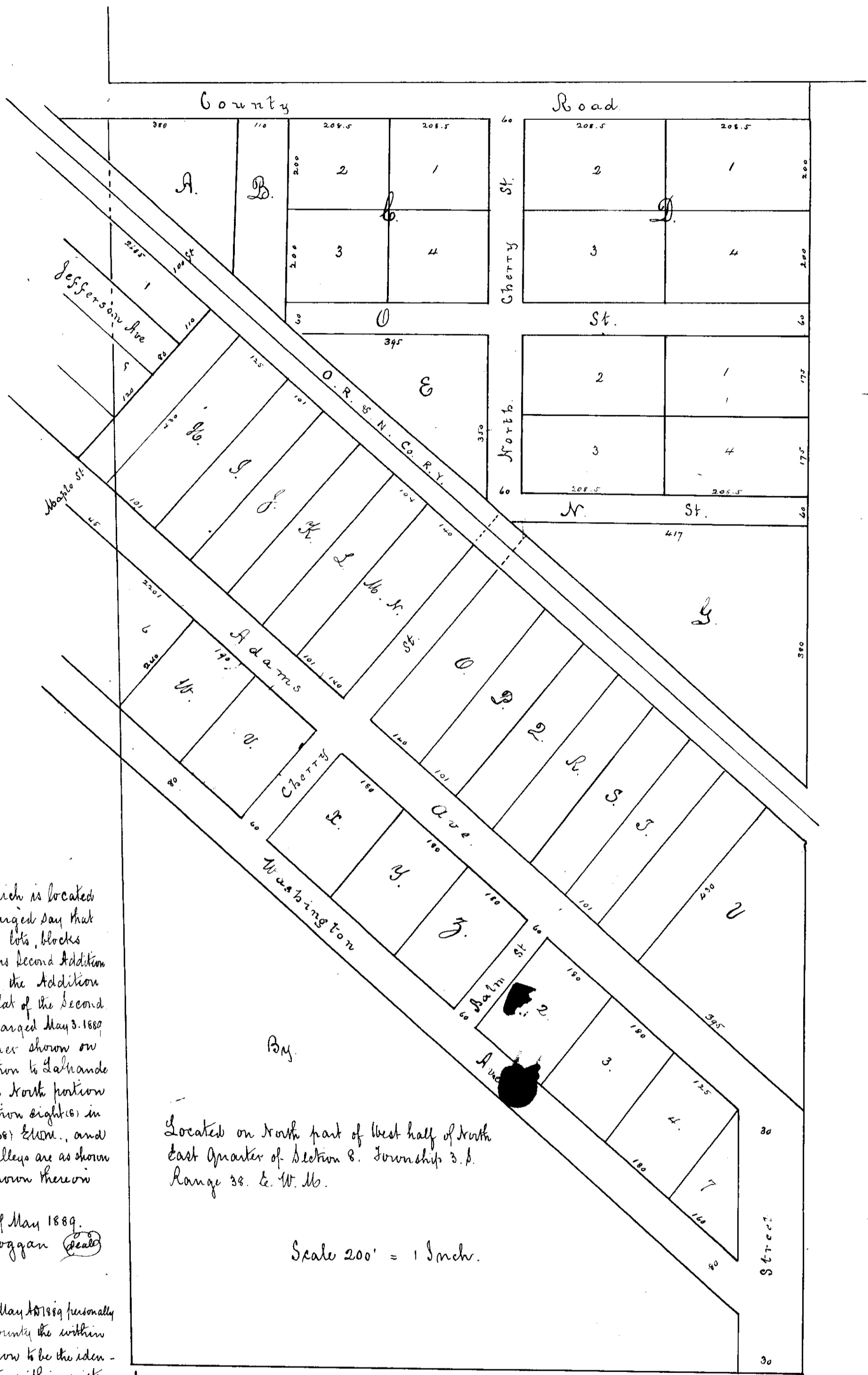

Revised and Enlarged. May 3rd 1889



I, Emma L. Coggan, owner of the land on which is located Coggan's Second Addition as revised and enlarged say that the revised and enlarged Plat contains the same lots, blocks streets and alleys as shown on the Plat of Coggan's Second Addition to the City of La Grande Union County Oregon, with the Addition of other lots streets and Alleys as shown on the Plat of the Second Addition to La Grande Oregon as revised and enlarged May 3, 1889 that I caused the same to be platted in the manner shown on said revised and enlarged Plat of Coggan's Addition to La Grande Oregon the land embraced therein being from the North portion of the West half of the North East quarter of Section eight (8) in Township three (3) south of Range thirty eight (38) E.W.M., and the measurements of the lots blocks streets and Alleys are as shown on said Plat, and the streets and Alleys as shown thereon are hereby dedicated to Public use forever.
