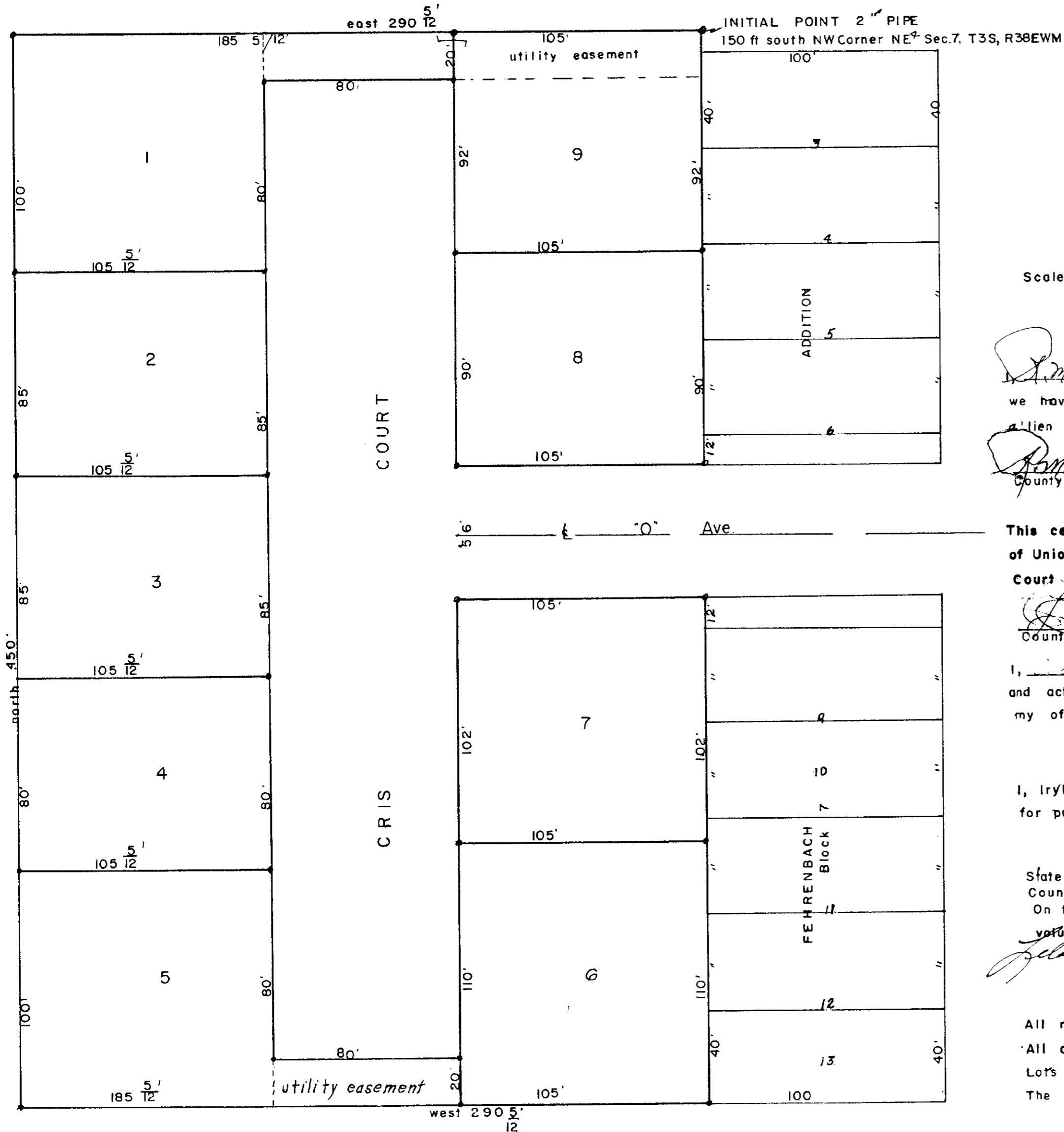

The initial point of the survey is designated by a two inch iron pipe thirty six inches long and driven six inches below surface of ground. Said initial point being 150 feet south of Northwest corner of northeast quarter of section 7, T3S, R38EWM. Said initial point also being on west property line of lot 2 Block 7 of Fehrenbach Addition to La Grande, Oregon; thence south 450 ft.; thence west 290 5/12 ft.; thence north 450ft.; thence east 290 5/12 ft. to initial point. The above described land is situated in NE 1/4 of NW 1/4 of section 7, T3S, R38EWM.

Restrictive Covenants

- All residential buildings shall have minimum of 1200 sq. ft.
- All construction to be minimum of F.H.A. property standards
- Lots 6, 7, 8, 9, shall be no more than one story over basement.
- The exterior of all construction shall be completed within one year from date of starting construction
