

NARRATIVE

This partition was done at the request of Gust Tsiatsos. The purpose of this partition is to create additional building sites on an existing tract of land. I base the location of the exterior on Minor Partition Plat Number 1996-05. The tract to the West of this partition was transferred by deed microfilm number 20041409 on the basis of boundary line adjustment with the adjoining ownership to the North. This partition creates an access easement for parcels 1 and 2 to accommodate a shared driveway, as well as creating a 40 ft. storm drainage easement along the East side of Parcel 3. Volume 83, page 96 grants a utility easement with no specific location. I find the utility lines for which the utility easementwas granted, fall within the dedicated right of way of the adjoining streets. I find no other unusual conditions on this partition.
