

NARRATIVE

South into L Street

West and 5.5 feet South

This partition was done at the request of Norma Gillis. The purpose of this partition is to create the two additional parcels as shown. I base the location of Block 9 on the found monuments from previous surveys as shown. I establish the Easterly lines of blocks 4 and 9 by driving a line from the found monument at the centerline of East N Avenue to a point 8.34 (record offset distance of survey number 009-2005) North of the found pin set by survey number 029-1996. I establish the West line of Blocks 4 and 9 by driving a line from the found monument at the Southeast corner of Block 8, North to the found monument of Walters Subdivision, and offsetting the line 60 feet East. I locate the centerline of East N Avenue by driving a line from the found monument at the East end of the street, West to a point 30 feet South of the found pin of Walters Subdivision. Having established these lines, I locate Blocks 4 and 9 by standard proportion. This fits the record information of the surveys cited in the reference material. I find the fences to be away from the true lines as shown. There is an existing overhead power line along the North line of the tract that has no easement. There is an easement for an irriaation ditch cited in deed volume 87 page 166, of no specific width or location, but I find no physical evidence of the ditch on site. The existing buildings along the South line of Parcel 3 encroach onto the street right of way as shown. I find no other unusual conditions on this partition.
