#### HISTORY OF ORIGINAL CORNER ESTABLISHED:

Corner originally established by Rufus S. Moore under GLO contract Number 382, dated March 23, 1881. Surveyor General record states: Set basalt stone 14"x8"x5", from which: A 22" diameter Pine bears S 54° W, 211 lks.

In 1998, Gregory T. Blackman brought this corner to county
standard. Union County Monumentation record states:
At surveyed proportionate position, I set a 2 1/2" x 30"
aluminum pipe with aluminum cap, 33 inches in the ground
form which:
A 5/8"x30" rebar with 1 1/2" aluminum cap marked 1/4 18 RP
bears N 67° E, a distance of 29.70 feet.
A 5/8"x30" rebar with 1 1/2" aluminum cap marked 1/4 19 RP bears S 4° E,
a distance of 33.49 feet.
A power pole bears S 75° W, a distance of 131.33 feet.
A 6" diameter Ponderosa Pine bears N 8° W, a distance of 13.54 feet,
marked X BT.

#### DESCRIPTION OF CORNER EVIDENCE FOUND:

Found a 2 1/2" aluminum pipe with aluminum cap, marked as shown below, 2" above ground in a 1 ½' diameter collar of stone. From which: A 5/8"x30" rebar with 1 1/2" aluminum cap marked 1/4 18 RP bears N 67° E, a distance of 29.70 feet. A 5/8"x30" rebar with 1 1/2" aluminum cap marked 1/4 19 RP bears S 4° E, a distance of 33.49 feet. An 18" Ponderosa Pine bears N 8° W, a distance of 13.54 feet, alive and vigorous with a healed blaze. I find that the Southwest bearing object (power pole) taken by Mr. Blackman has been replaced and does not match bearing and distance.

## DESCRIPTION OF MONUMENT AND ACCESSORIES I ESTABLISHED TO PERPETUATE THE ORIGINAL LOCATION OF THIS CORNER:

From the aluminum pipe monument:

NEW BEARING OBJECT:

A 5/8" x 30" iron pin bears South 35° West, a distance of 64.55 feet, with a 1 1/2" aluminum cap marked UNION COUNTY SURVEYOR SW RP.


I found a steel fencepost approximately 1 foot North of corner monument. Corner falls approximately 7 feet North of the centerline of Hardy Road.




