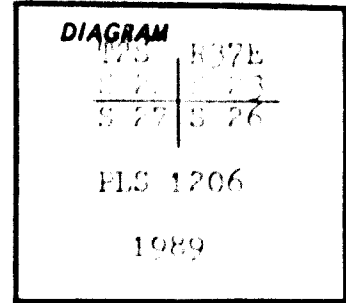


CERTIFIED RECORD OF LAND CORNER MONUMENTATION

History of original corner establishment: Henry Meldrum surveyed the majority of the subdivision lines of Township lines of Township 2 South, Range 37 East, W.M. under GLO contract no. 450, dated June 11, 1882.



Record states:

Set basalt stone 20x12x3 ins. 15" in the ground, mkd. with 2 notches on S and E edges. From which:

A pine 10" diam. bears N 28 W 23 lks. mkd. R37E S22 BT.

A pine 12" diam. bears N 10 E 24 lks. mkd. T2S S23 BT.

A fir 7" diam. bears S 60 E 14 lks. mkd. S26 BT.

A fir 5" diam. bears S 38 W 23 lks. mkd. S27 BT.

From page 12; East on a random line between sections 23, 26... .5 chains ravine course S 20 E.

From page 14; North between sections 22, 23... 1.3 chains ravine course SE.

Description of corner evidence found: After a thorough and unsuccessful search for the original corner stone and bearing trees, the original topographic calls were relied upon to re-establish the corner point. The hillside where the corner is located had been logged many years ago and there are traces that a forest fire burned through the area. The proportional distances from the 1/4 corners to the north and south match both topographic calls to the ravine. See detailed drawing regarding the location of this corner on the map of survey for WTD.

Description of monument and accessories I established to perpetuate the original location of this corner:

At the corner point as re-established from the topographic calls, Set 2 1/2" brass cap on 1" iron pipe, projecting 6" above the ground with 36" dia. stone mound. Set fence post 3 ft. west.

From which:

A 10" Douglas Fir bears N 87 W 13.6 ft. mkd. T2S R37E S22 BT.

A 7" Tamarack bears N 88 E 10.2 ft. mkd. T2S R37E S23 BT.

A 11" Tamarack bears S 43 1/2 E 22.6 ft. mkd. T2S R37E S26 BT.

A 12" Tamarack bears S 34 1/2 W 8.9 ft. mkd. T2S R37E S27 BT.

Attached U.S.F.S. 54-9 signs and 54-3 tags to bearing trees.
