History of original corner establishment:

A pine, 9 ins. diam. bears N38°W, 17 lks. dist. marked T3S R34E S2 BT. A pine 12 ins. diam. bears S31°W, 10 lks. dist. marked T3S R34E S11 BT. A pine 12 ins. diam. bears S67°E, 22 lks. dist. marked T3S R34E S12 BT."

Description of corner evidence found:

The corner falls on a steep north slope in very dense lodgepole. Several hours were spent searching for the corner before establishing a surveyed position and after surveying into the area. No trace of the corner could be found.
