
CERTIFIED RECORD OF LAND CORNER MONUMENTATION

HISTORY OF ORIGINAL CORNER ESTABLISHMENT:

Corner originally established by Timothy W. Davenport GLO contract number 102, dated July 20, 1863. Surveyor General record states:

Set post for section corner in mound of earth, with charred stake, pits, trench as per instructions.

DESCRIPTION OF MONUMENT AND ACCESSORIES I ESTABLISHED TO PERPETUATE THE ORIGINAL LOCATION OF THIS CORNER:

At the position determined by said survey, I set a 2 ½ x 30 aluminum monument marked as shown below, 26 in the ground, from which:

NEW BEARING OBJECTS:

A $5/8" \times 30"$ iron pin with aluminum cap marked BGB SURVEY MARKER S35 RP, bears North 45° East a distance of 12.72 feet.


A $5/8" \times 30"$ iron pin with aluminum cap marked BGB SURVEY MARKER S2 RP, bears South 77° East a distance of 17.49 feet.

A $5/8" \times 30"$ iron pin with aluminum cap marked BGB SURVEY MARKER S3 RP, bears South 5° West a distance of 59.10 feet.

A $5/8" \times 30"$ iron pin with aluminum cap marked BGB SURVEY MARKER S34 RP, bears North 59° West a distance of 16.08 feet.

Raised a small mound of stone around monument.




