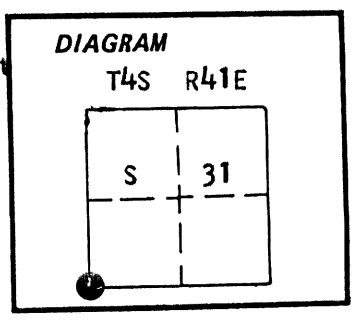


CERTIFIED RECORD OF LAND CORNER MONUMENTATION (45 40)

History of original corner establishment:  
Corner originally established by John H. Stone under GLO contract number 235 dated July 6, 1875. Surveyor General record states:

Set stone 16x7x5 as per instructions for the corner to Townships 4 and 5 South, Ranges 40 and 41 East



Description of corner evidence found:

Stone 16"x7"x5" with grooves on 4 sides, too dim to get exact count.  
Found a 1 1/2"x24" pipe with brass washer marked CX 2 1973, in the mound of stone  
Pipe is unrecorded and was set by William W. Briggs Oregon Reg. Engineer No. 3780.

See map of survey numbers 31-86 and 22-86 filed in the office of the Union County Surveyor  
Description of monument and accessories I established to perpetuate the  
original location of this corner: At the pipe position, I set a 2 1/2"x30" aluminum pipe with  
aluminum cap marked as shown 26" in the ground and raised a mound of stone with  
a 3 foot base to top of cap, from which:

A 5/8"x30" iron pin with plastic cap marked BGA Survey Marker bears N 53° E, 14.81 feet,

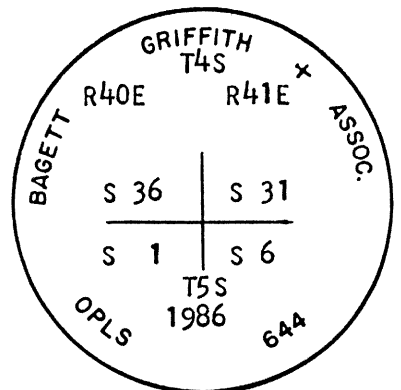
A 5/8"x30" iron pin with plastic cap marked BGA Survey Marker bears S 52° E, 18.07 feet.

A 5/8"x30" iron pin with plastic cap marked BGA Survey Marker bears S 51° W, 15.81 feet,

A 5/8"x30" iron pin with plastic cap marked BGA Survey Marker bears N 41° W, 15.84 feet.

Set a steel fence post approximately 5 feet North with a 54-9 sign attached. Buried stone south of monument, and place the pipe inside the aluminum cap.  
Corner set: 9/17/86

Witness: Greg Blackman, Rick Robinson, David Dahlstrom



Brass washer marked OPLS 644 nailed to BT blaze.  
Used steel tape and magnetic compass with 20° East declination. Distances to the BTs are to a 50d spike set in right side of tree when facing tree, unless otherwise stated.
