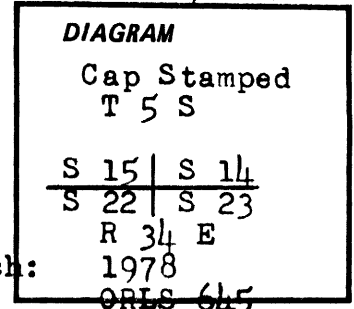


CERTIFIED RECORD OF LAND CORNER MONUMENTATION

N-17

History of original corner establishment:

Corner was established in 1882, by Rufus S. Moore, under General Land Office Contract No. 451. Surveyor General's records state: Set a post 4 ft. long, 4" square, 24" in the ground for cor. to Sec's. 14, 15, 22 & 23, marked T 5 S S 14 on NE, R 34 E S 15 on NW, S 22 on SW and S 23 on SE face with 3 notches on south and 2 notches on east edges from which:
 A pine 7" dia. bears S 23 E, 31 lks. dist. marked T 5 S R 34 E S 23 BT.
 A pine 12" dia. bears S 58 W, 33 lks. dist. marked T 5 S R 34 E S 22 BT.
 A pine 8" dia. bears N 38 W, 63 lks. dist. marked T 5 S R 34 E S 15 BT.
 A pine 9" dia. bears N 77 E, 46 lks. dist. marked T 5 S R 34 E S 14 BT.



Description of corner evidence found:

At assumed corner location I found no trace of the original section corner, nor any evidence of the bearing trees, as there was evidence of a fire in the early 1900's through this area and of which possibly destroyed all evidence of the original corner.

Description of monument and accessories I established to perpetuate the original location of this corner:

Assuming this corner to be lost, I then used double proportioning measurements to re-establish this section corner, thus I set a 2 1/2" brass cap on a 30" galv. iron pipe, and being stamped as shown above. There were no stone within the specified area, therefore did not place any stone about the monument.

New bearing trees:

A tamarack 8" dia. bears S 42 E, 66.33 feet scribed T 5 S R 34 E S 23 BT.
 A tamarack 8" dia. bears S 08 W, 21.56 feet scribed T 5 S R 34 E S 22 BT.
 A tamarack 9" dia. bears N 76 W, 27.32 feet scribed T 5 S R 34 E S 15 BT.
 A pine 6" dia. bears N 48 E, 34.67 feet scribed T 5 S R 34 E S 14 BT.
