

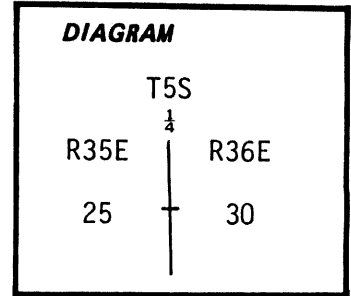
CERTIFIED RECORD OF LAND CORNER MONUMENTATION

Index File No. T-1

History of original corner establishment:

In 1882, under GLO Contract No. 397, J. Cooper set a post 3½ ft. long, 3 ins. square 18 ins. in the ground near the summit of Ridge in heavy open pine timber for 1/4 sec. cor. marked 1/4 S on the east and west faces from which:

- A Pine 3 ft. diam. bears N22°W 12 lks.  
Distance marked 1/4 S BT.
- A Pine 24 ins. diam. bears N 35° E 22 lks.  
Distance marked 1/4 S BT.



Description of corner evidence found:

At corner location found a P. Pine stump 25" diam. 4.3' tall, rotted. Found remains of blaze lying face down 2 ft. south of stump with visible scribing "1/4 S BT" for N.W. BT. Found burnt stump fallen over for N.E. BT. The face where scribing would be has been burnt out.

Could find no evidence of original corner post.

Establish a point for the corner position at record bearing and distance (S22° E 7.92 ft) from standing stump. The fallen over stump fits record bearing and distance (N35°E 14.52 ft for NE BT.)

Description of monument and accessories I established to perpetuate the original location of this corner:

At point established for the corner position, set 2½"x30" galvanized pipe with brass cap stamped:

Set pipe 24" in ground with mound of stone and dirt to cap.

- A P. Pine 16" dia. bears S68½°W, 34.3 ft., scribed "1/4 S25 BT."
- A P. Pine 11" dia. bears S33°E, 41.1 ft., scribed "1/4 S30 BT."

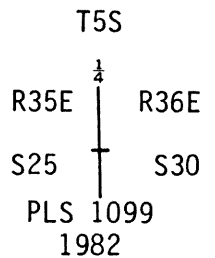
Attached signs and painted trees per Standard Specifications for Cadastral Surveys, U.S.F.S., Region 6, October, 1979. Attached 54-2 and 54-4 sign to metal post 6 ft. north of corner.

Corner falls on slight south slope 300' south of summit of ridge (E-W) and 135' north of location tag on 3 ft. Ponderosa Pine on north side of old E-W logging road.

Compass Declination: 19°E
