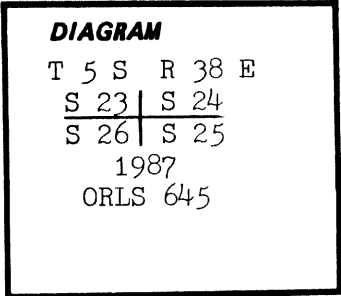


CERTIFIED RECORD OF LAND CORNER MONUMENTATION

History of original corner establishment:

This section corner was set by deputy surveyor W.B. Barr, under Contract No. 388, dated May 7, 1881. He states he set a marked basalt rock 14" x 12" x 5" for the Sec. Cor 23, 24, 25 and 26 from which:

- A pine 50" dia. bears S 40 E, 10 lks. dist.
- A pine 15" dia. bears S 30 W, 55 lks. dist.
- A pine 10" dia. bears N 69 W, 124 lks. dist.
- A pine 20" dia. bears N 76 E, 150 lks. dist.



Description of corner evidence found:

At the assumed section corner location I found a basalt stone 14" x 12" x 5" lying flat on the ground with 2 notches on the south side and one notch on the east side from which I also found a large stump hole with a large badly burnt stump lying out of the hole and bearing S 40 E, 7 feet from the stone. Area has been logged and burnt thus no evidence exists of the other three bearing trees.

Description of monument and accessories I established to perpetuate the original location of this corner:

With the marked stone agreeing to the GLO description I accepted the center of the stone as being the true section corner. I then set an Alum. cap on a 2" x 30" pipe, with a magnet fixed in the cap, at the corner location. I buried the pipe to within 10" above the surface of the ground. I then placed a mound of stone 4 feet dia. and 1½ feet high around the pipe and covering the monument. I buried the basalt stone upside down and on the west side of the monument. From which I set four new bearing trees:

- A pine 13" dia. bears N 68 45 W, 29.00 feet and scribed T 5 S R 38 E S 23 BT.
- A pine 11" dia. bears N 59 45 E, 39.40 feet and scribed T 5 S R 38 E S 24 BT.
- A pine 9" dia. bears S 30 15 E, 37.04 feet and scribed T 5 S R 38 E S 25 BT.
- A pine 6" dia. bears S 52 15 W, 71.20 feet and scribed T 5 S R 38 E S 26 BT.
