

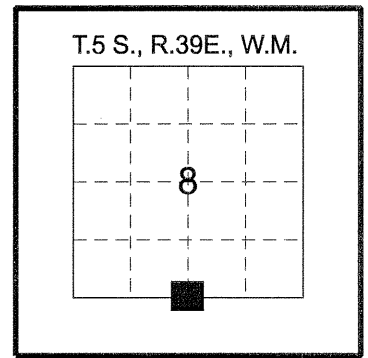
CERTIFIED RECORD OF LAND CORNER MONUMENTATION

J-7

HISTORY OF ORIGINAL CORNER ESTABLISHMENT:

The subdivision of T5S, R39E, W.M. was originally surveyed by David P. Thompson under General Land Office Contract No. 103, approved February 15, 1864. The field notes for this survey state:

"Set post for 1/4 section corner in mound of stone"



DESCRIPTION OF CORNER EVIDENCE FOUND:

Found a 3 ft. diameter mound of stone with hollow area at center, position fit search based on Oregon Department of Transportation Right of Way Map No. 6B-35-13.

DESCRIPTION OF MONUMENT AND ACCESSORIES I ESTABLISHED TO PERPETUATE THE ORIGINAL LOCATION OF THIS CORNER:

At center of found mound of stone:
Set a 3 1/4 in. diameter aluminum cap on a 5/8 in. diameter by 30 in. iron rod (rebar), driven 20 inches into the ground, a t-post placed alongside, placed rock mound around monument, marked as shown:

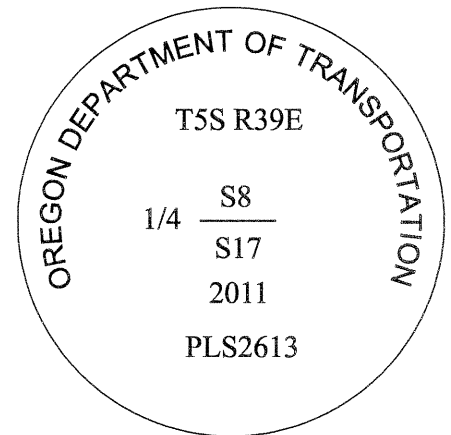
From which I establish the following reference monuments:

A silver Berntsen DEEP-1 magnet, buried 4 in. into the ground, bears N45° E, 7.60 ft.

A pink Berntsen DEEP-1 magnet, buried 4 in. into the ground, bears S46° E, 7.90 ft.

A 5/8 in. diameter by 30 in. long smooth iron rod with a 1 1/2 in. diameter aluminum cap, driven 20 in. into the ground, mkd.: "ODOT SW" bears S32° W, 9.99 ft.

A 5/8 in. diameter by 30 in. long iron rod (rebar) with a 1 1/2 in. diameter aluminum cap, driven 19 in. into the ground, mkd.: "ODOT NW" bears N70° W, 10.97 ft.



Accessories taken with steel tape and hand compass set at 19° East declination.
