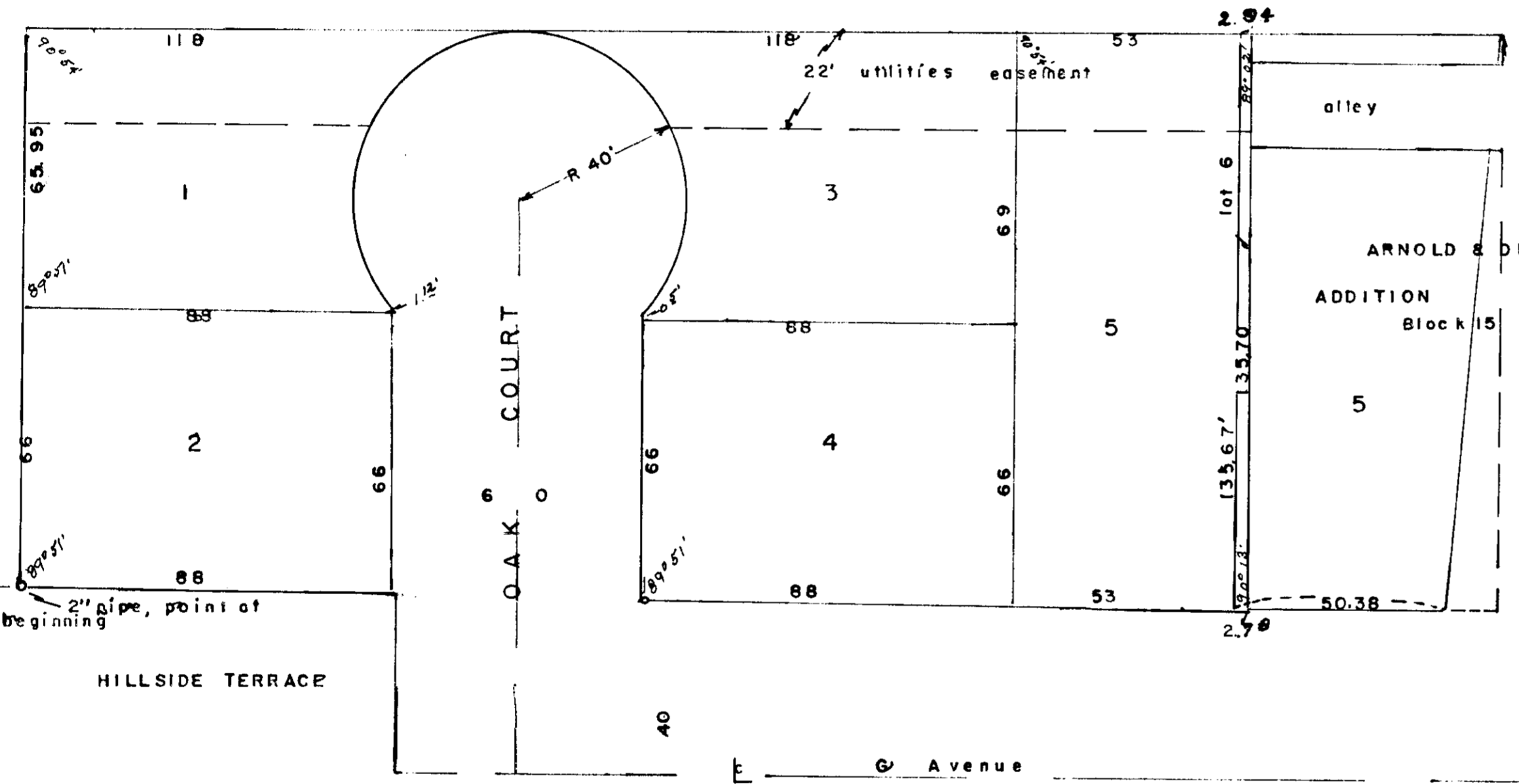

I, James G. Voelz, certify that I am a registered land surveyor in the State of Oregon and have surveyed the land as shown on accompanying plat. The initial point of the survey is designated by a two inch galvanized iron pipe thirty six inches long and driven six inches below surface of ground. All corners are placed in accordance with ORS 92.060. LEGAL DESCRIPTION: Beginning at a point 1845.88 feet west and 251.95 feet south of the east one quarter corner of Section 7, T3S, R38E WM. Said point all so being on the north boundary of Hillside Terrace Addition to La Grande, Oregon and S 89° 07' E 121.33 feet from northwest corner of said addition, From point of beginning so described running thence easterly on north side of Hillside Terrace and the north side of G Avenue 291.78 feet more or less to the southwest corner of lot 5 of Block 15 of Arnold and Dray's Addition to La Grande, Oregon. Thence northerly on west boundary of said addition 135.70 feet to the south boundary of tract of land as described in deed book 144 at page 22 of deed of records of Union County. Thence west 291.94 feet to the southwest corner of land as described in book 141 at page 598 of deed of records of Union County. Thence south 131.95 feet to point of beginning SITUATE in NW 1/4 of Section 7, T3S, R38E WM of La Grande, Oregon.
