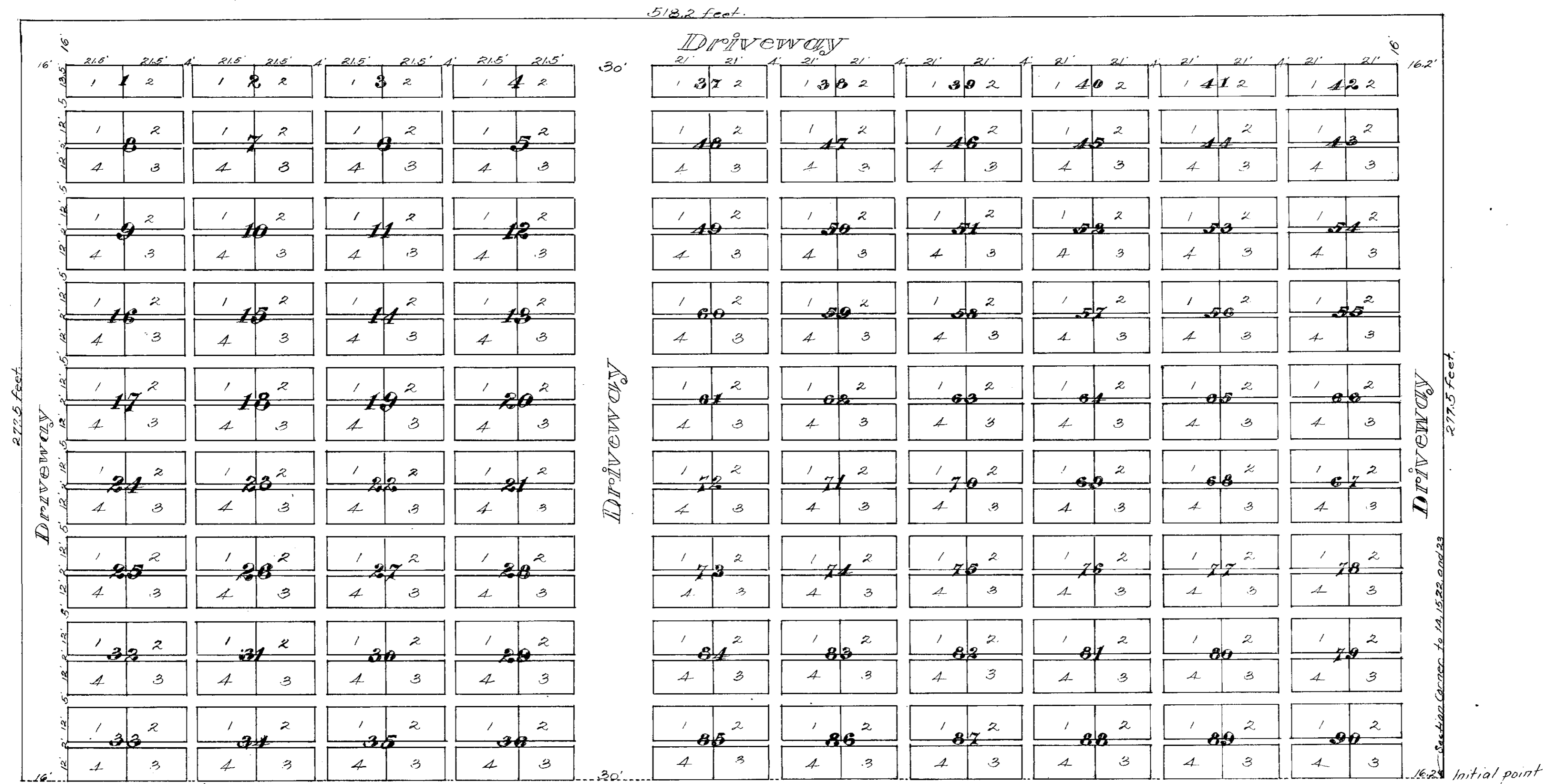
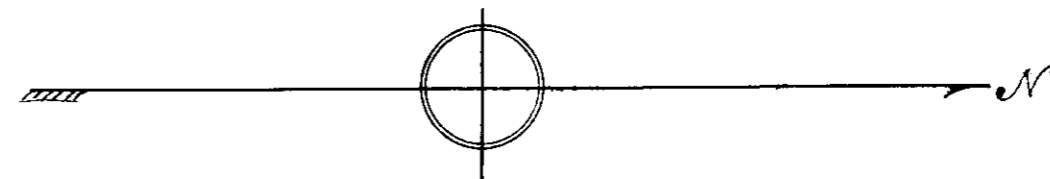


Plot of Second Addition to NORTH POWDER CEMETERY NORTH POWDER, ORE.

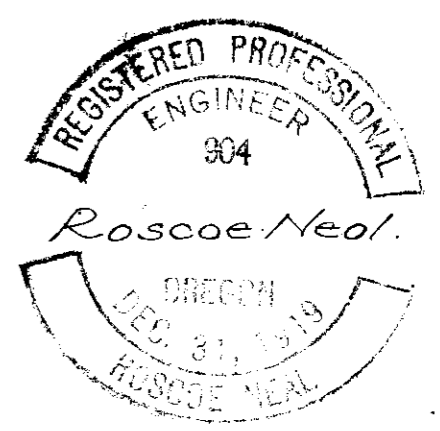

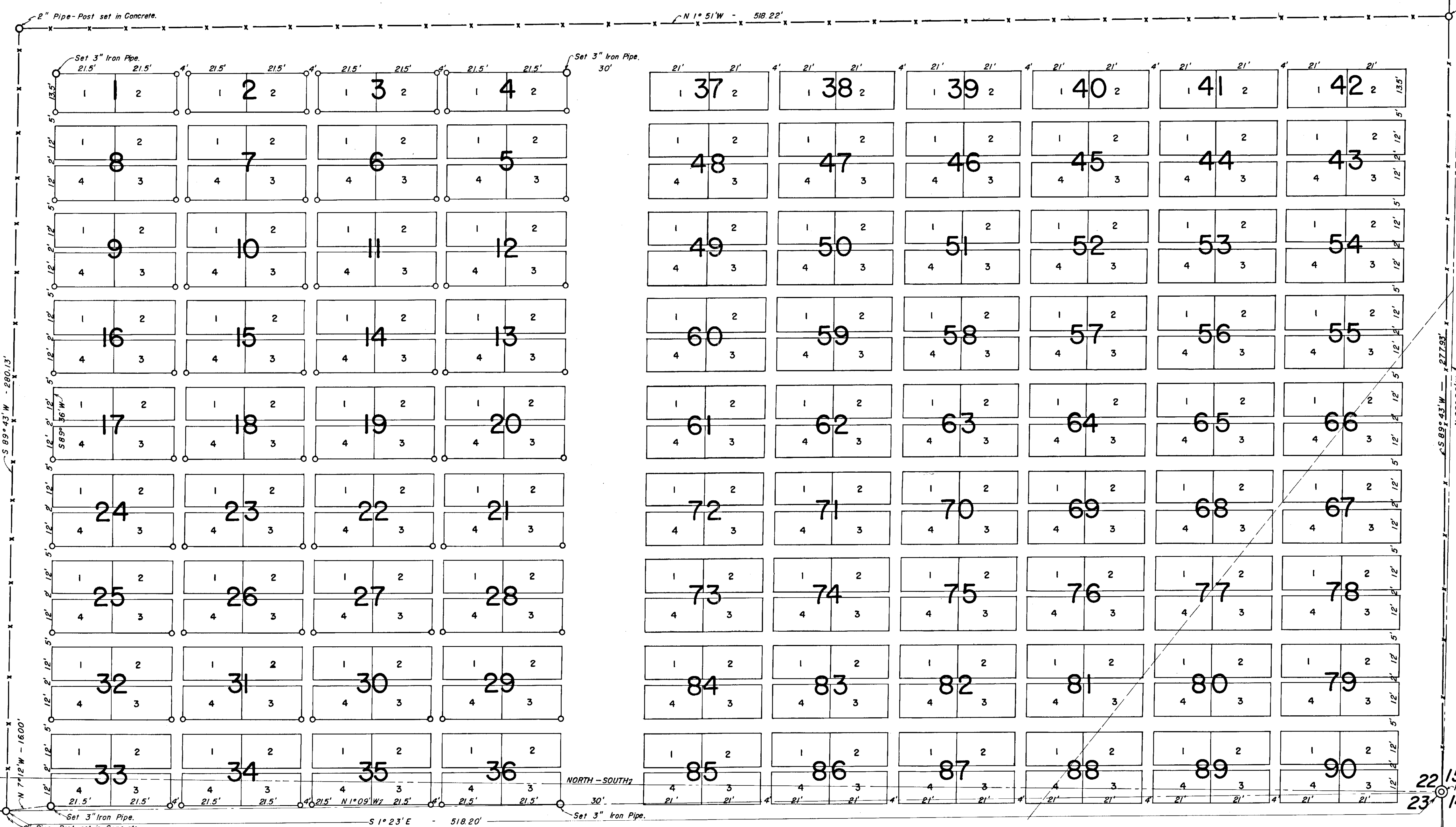
