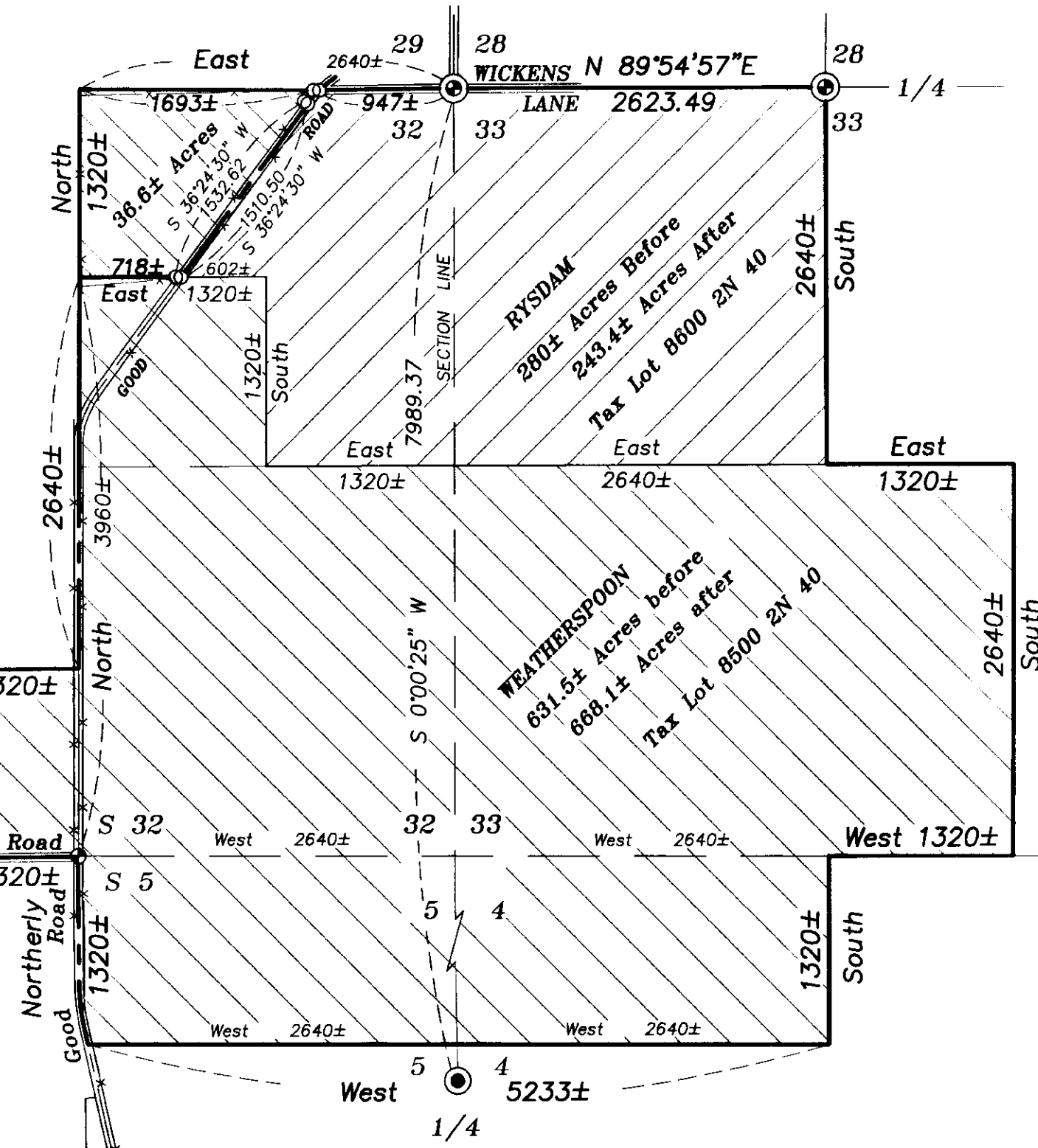
BASIS OF BEARING

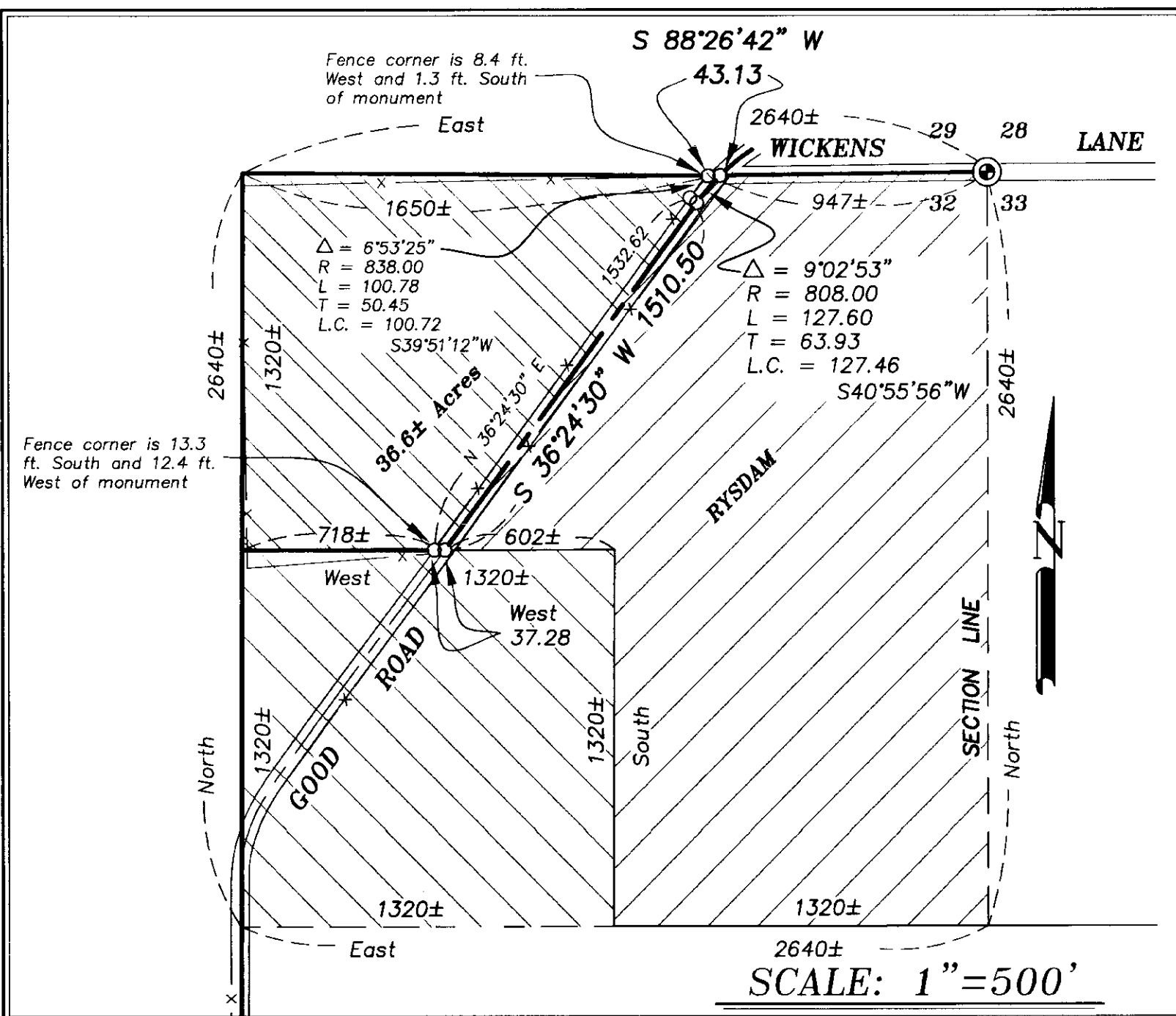
