This survey was done in preparation for a Partition of the North Half of Lots 7, 8, 9, 10, and 11 of Block 153 of CHAPLIN'S ADDITION to La Grande. The partition was ordered by Paul Robinson. This survey is intended to clarify the elements that I used to establish the exterior of the blocks and the positions of the lots. I find and hold monuments set by survey Number 79-80, which also found lead plugs at the intersections of Spruce and "S" and Spruce and Jackson, and at "S" and Greenwood. Survey Number 90-71 established the intersection of Greenwood and "T", which I accepted. I also find a "PK" nail at the intersection of Greenwood and Court Street, which fits the proportioned position of Court Street from North Fir to Spuce Street. I then proportion the positions of Spruce and "T" and Spruce and Court Street from the found Lead Plugs at Spruce and Jackson and Spruce and "T". I find that the lots and blocks fit very well with the existing conditions. I find no encroachments or unusual conditions with this survey.
