- Road #104 - Wolf Creek overcrossing .66 miles;
- Road #103 - .02 miles Coughnour Lane to North Powder Interstate west side of Interstate 80N;
- Road #23 - 3.0 miles north of McCanse - Olsen Road to Clover Creek interchange and north to Hibbard Glenn private drive;


have been duly constructed by the Oregon State Highway Division in accordance with plans and specifications; and


