WHEREAS, Union County received a Petition to vacate portions of streets in the Alicel area on August 6, 1986;

WHEREAS, proper notice of the pendency of the petition was given per ORS 271.010 and the County Court held a public hearing on October 1, 1986, to accept testimony on the petition;

WHEREAS, the County Court received opposition to the petition;

WHEREAS, ORS 271.030 allows the County Court to grant the petition in part when opposition is expressed.

NOW THEREFORE, IT IS HEREBY ORDERED that the following dedicated right-of-ways be vacated to adjacent properties:

Fir Street - that portion 80 feet in width extending east about 870 feet from the centerline of former Main Street to the west boundary of Seventh Street;

Sixth Street - that portion 80 feet in width from the south boundary of Stanley Lane to the north boundary of Fir Street;

Fifth Street - that portion 80 feet in width beginning about 207 feet south of Stanley Lane County Road and extending south 250 feet to the north boundary of Fir Street;

Pine Street - that portion 80 feet in width 15 feet west of the east boundary of Fifth Street and extending east about 235 feet to the west boundary of Sixth Street; and that portion about 80 feet in width beginning at the east boundary of the alley between Main and Fifth Streets extending 115 feet east to a line 15 feet east of the west boundary of Fifth Street;

Alley between Main & Fifth Streets - that portion about 20 feet in width beginning 127 feet south of Stanley Lane County Road or more particularly described as the north boundary of Pine Street and extending south about 330 feet to the north boundary of Fir Street.




Fifth Street - that portion 15 feet on the west
