SECTION 4: PUBLIC HEARING



RE: MT EMILY RD - SECTION B

ORS 368.341 (1) allows the County Court to initiate vacation proceedings by adopting a resolution which includes the following:

- (a) A declaration of intent to vacate property;
- (b) A description of the property proposed to be vacated; and
- (c) A statement of the reasons for the proposed vacation.

Once the resolution is adopted the county governing body shall direct the county road official to prepare and file with the county governing body a written report containing the following:

- (a) A description of the ownership and uses of the
- property proposed to be vacated;
 (b) An assessment by the county road official whether the vacation would be in the public interest; and
- (c) Any other information required by the county governing body.

Upon receipt of the report the Court shall establish a time and place for a hearing to consider whether the proposed vacation is in the public interest.

Notice of the hearing shall be provided under ORS 368.401 to 368.426 by posting and publication and by service on each person with a recorded interest in any of the following:

- (a) The property proposed to be vacated;
- (b) An improvement constructed on public property proposed to be vacated; or
- (c) Real property abutting public property proposed to be vacated.

After receiving testimony at a public hearing the Court shall determing whether vacation of the property is in the public interest and shall enter an order or resolution granting or denying the vacation of the property under ORS 368.326 to 368.366.

An order or resolution shall:

- (a) State whether the property is vacated;(b) Describe the exact location of any property vacated;

When an order or resolution becomes final, the county governing body shall cause the order to be recorded with the County Clerk and cause copies of the order to be filed with the County Surveyor and the County Assessor. The order or resolution is effective when the order or resolution is filed.


