WHEREAS, the Copcopi Subdivision recorded on June 8, 1992 dedicated for public use a 40 foot right-of-way and 45 foot radius cul-de-sac for a portion of Cottonwood Road;

WHEREAS, the dedicated right-of-way and cul-de-sac are described in Attachment "A" and includes about 0.62 acres;

WHEREAS, the Board of Commissioners advertised and held a public hearing on December 2, 1992 to accept testimony, deliberate and potentially make a decision to accept the dedicated portion of Cottonwood Road in the County Road System;

NOW THEREFORE, BE IT ORDAINED BY THE ^{Commission} COURT OF THE COUNTY OF UNION, STATE OF OREGON:

SECTION 1: ROAD DESIGNATION

A portion of Cottonwood Road dedicated for public use in the Copcopi Subdivision as filed in the office of the Union County Clerk and described in Attachment "A" is hereby designated as a part of the Union County Road System.

ATTACHMENT "A"

LEGAL DESCRIPTION
COTTONWOOD ROAD

A parcel of land known as COTTONWOOD ROAD as platted and dedicated on the plat of " COPCOPI SUBDIVISION " as filed in the office of the Union County Clerk in Plat Cabinet Number A 306 & 307, more particularly described as follows, with reference to the plat of COPCOPI. SUBDIVISION;

Beginning at the Northeast corner of COTTONWOOD ROAD,
(formerly known as RUSSELL STREET) ;

Thence; running along the exterior of COTTONWOOD ROAD
as dedicated the following courses;

Thence; N 84°51'21" W, along the North line of
COTTONWOOD ROAD, (Russell Street) a distance of
9.84 feet;

Thence; N 48°02'34" E, a distance of 54.77 feet;

Thence; N 1°47'54" E, a distance of 83.70 feet;

Thence; N 0°13'09" E, a distance of 200.22 feet;

Thence; N 88°16'40" W, a distane of 143.52 feet to the
intersection of a Cul-De-Sac with a radius of 45
feet;

Thence; around said Cul-De-Sac a distance of 48.28
feet, (long Chord bears S 78°09'13" W, 45.99
feet);

Thence; around said cul-de-sac a distance of 53.10
feet, (long Chord bears N 30°56'38" W, a distance
of 58.05 feet);

Thence; around said Cul-de-sac a distance of 47.52 feet
(long chord bears N 39°28'33" E, a distance of
45.34 feet);

Thence; around said cul-de-sac a distance of 80.14
feet, (long chord bears S 59°15'11" E, a distance
of 69.96 feet) to the South line of Lot 1 of
"COPCOPI SUBDIVISION";

Thence; S 88°16'40" E, along said South line of Said
Lot 1, a distance of 169.48 feet to the EAST line
of "COPCOPI SUBDIVISION", also being the East line
of Cottonwood Road;

Thence; S 0°05'03" W, along said East line of "COPCOPI
SUBDIVISION", a distance of 359.42 feet;

Thence; S 60°58'27" W, a distance of 84.00 feet to the
East end of Cottonwood Road (Russell Street) as
platted by "PARK ADDITION";

Thence; N 0°35'16" W, along said East end of Cottonwood
Road, (Russell Street) a distance of 40.00 feet
to the point of beginning of this description.
