COURT ORDER

In accordance with Chapter 2, Section 204 of the Uniform Building Code which states:

Sec. 204. In order to determine the suitability of alternate materials and methods of construction and to provide for reasonable interpretations of the provisions of this Code, there shall be and is hereby created a Board of Appeals, consisting of five members who are qualified by experience and training to pass upon matters pertaining to building construction. The Building Official shall be an ex-officio member and shall act as Secretary of the Board. The Board of Appeals shall be appointed by the County Court and shall hold office at their pleasure. The board shall adopt reasonable rules and regulations for conducting its investigations and shall render all decisions and findings in writing to the Building Official with a duplicate copy to the appellant and may recommend to the County Court such new legislation as it consistent therewith.

THEREFORE, it is HEREBY ORDERED that the following persons shall be the first members and Alternates of the Union County Board of Appeals, Building Inspection Division serving at the pleasure of the County Court.

It is further ordered that the Roadmaster for Union County, Oregon, be directed to cause notice of the hearing to be given by advertisement posted at the place holding County Court, Union County Courthouse, and at three public places in the vicinity of the road, at least thirty (30) days before the date set for hearing, and proof that the notice has been given shall be made by the Union County Roadmaster.

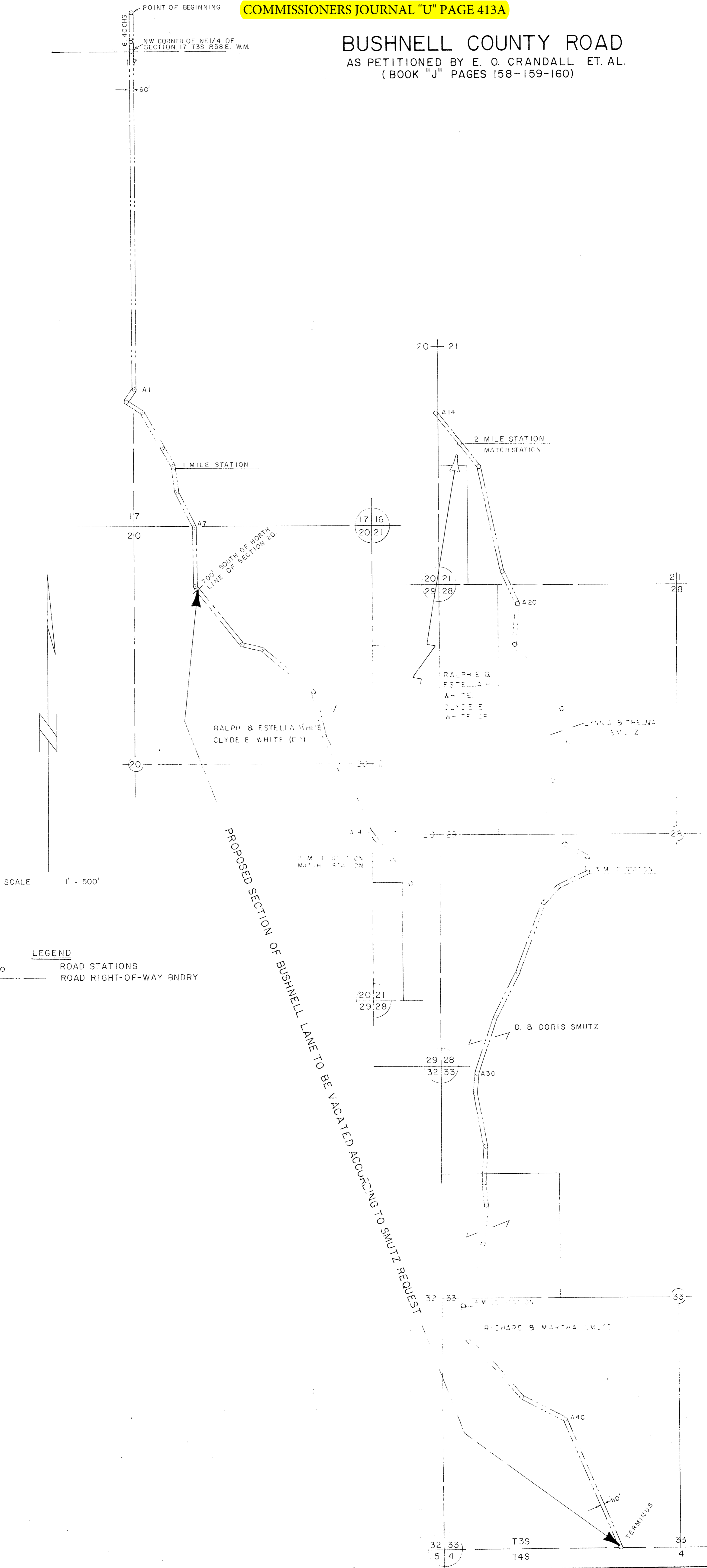
