COURT ORDER

PURSUANT TO Resolution adopted by the County Court, Union County, Oregon, on the 18th day of September, 1974, and in accordance with ORS 368.570, it is hereby ORDERED that the County Roadmaster examine that portion of Patten Street and Bell Street which is no longer used as a County road and make a report in writing on the road.

The report shall include the opinion of the Roadmaster as to whether the property proposed to be vacated, should be vacated, whether that portion of the road is a necessary part of the County road system, whether it will be advisable to preserve that portion of the road as a part of the general road system in the future, or whether the public will be benefited by the vacation of said portion of County road, and all other facts, matters, and things which are of importance to the County Court. Upon completion of the report, it shall be filed with the County Clerk.

ORDER OF ROAD VACATION

On this day this matter came on for hearing in the Court in session pursuant to ORS 368.570 and ORS 368.580 did consider the matter of the vacation of that portion of Whiskey Creek Road, No. 300, more particularly described as

Commencing at a point on the East Line of Section 23 township 3 South Range 37 East WM. From said point running thence westerly across section 23 and section 22 and terminating at junction at Elk Flat Road at approximate NE corner of NW 1/4 SW 1/4 of Section 21 Township 3 South Range 37 East, as the same appears on the attached Exhibit A.

FINDINGS OF FACT

The County Court finds that the said County road is burdensome to maintain, is not needed as a part of the County road system, and has not been used as a part of the said County road system for many years; and further finds that the landowners immediately adjacent to the road desire to have the road vacated.

The Court further finds that Boise Cascade Corporation is or may be dependent upon a portion of this road for access to remove timeber from the area. However, Boise Cascade Corporation is currently negotiating with the landowners for easement rights across the property.

The Court further finds that no other person or persons residing on the County road and depending thereon for access will be adversely affected by its closure.

O R D E R

IT IS HEREBY ORDERED that the portion of Whiskey Creek Road, No. 300, as above described, be vacated pursuant to the map attached hereto and marked Exhibit A. It is further ordered that this road vacation be effective sixty (60) days from the date of this hearing.

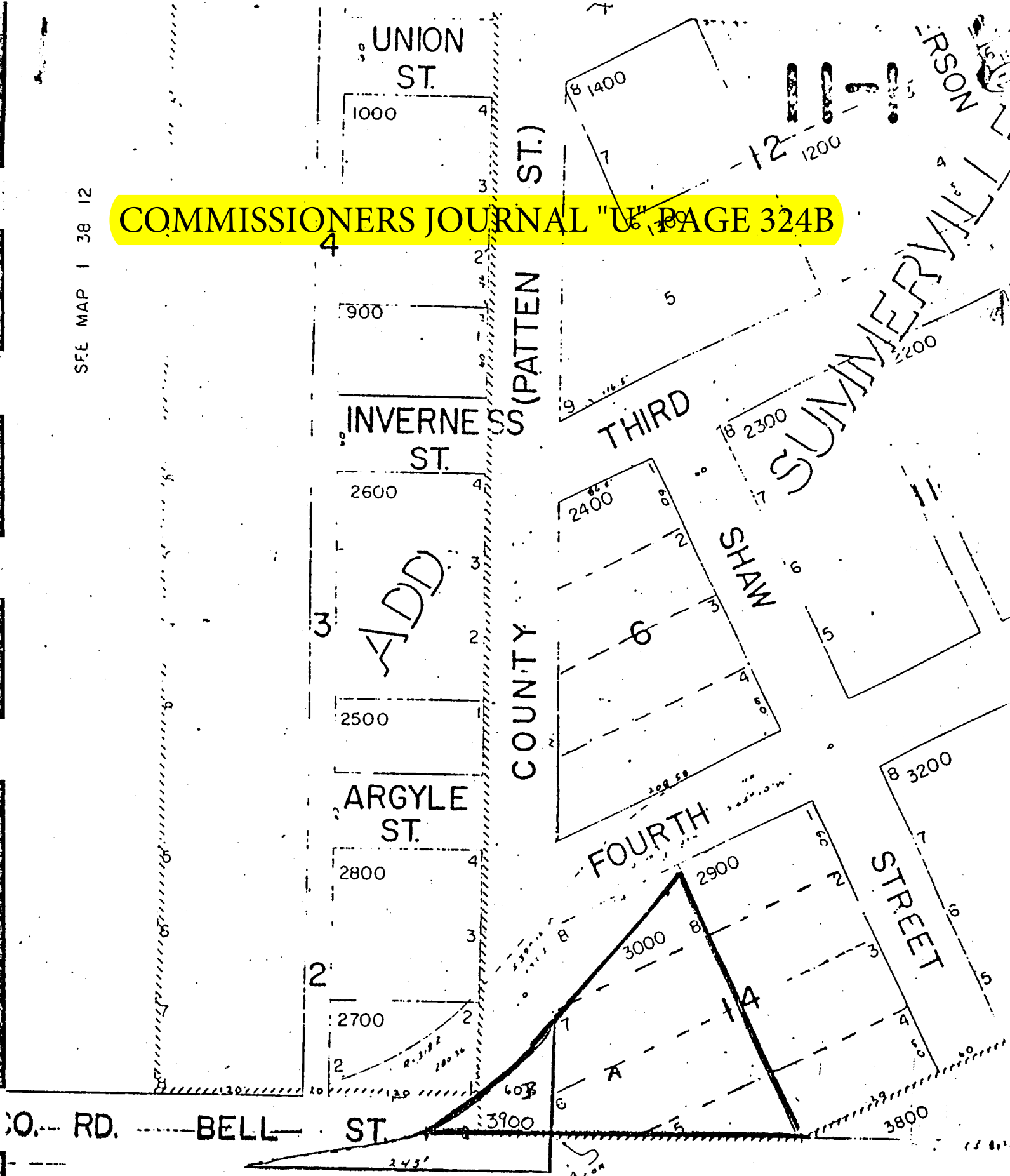

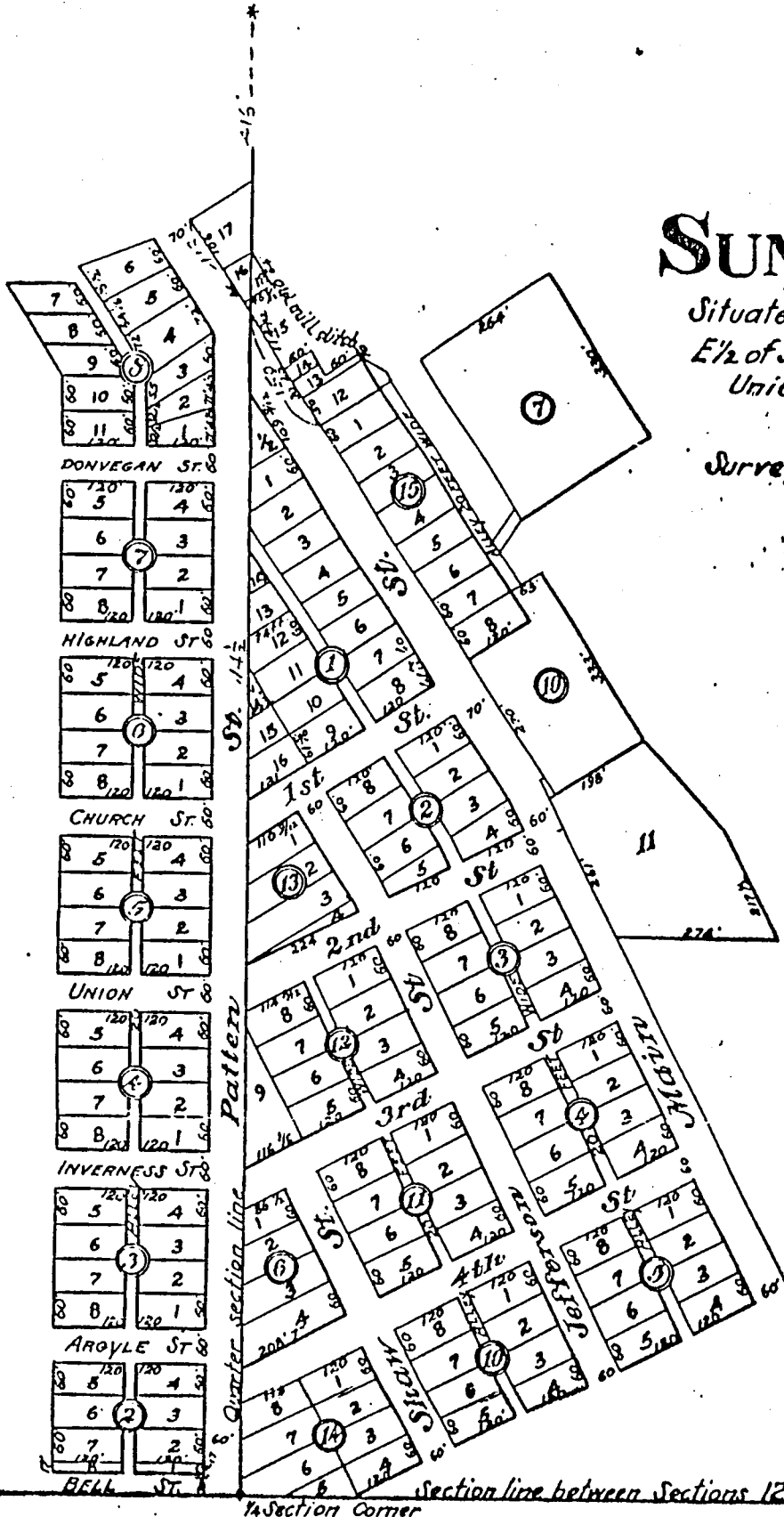

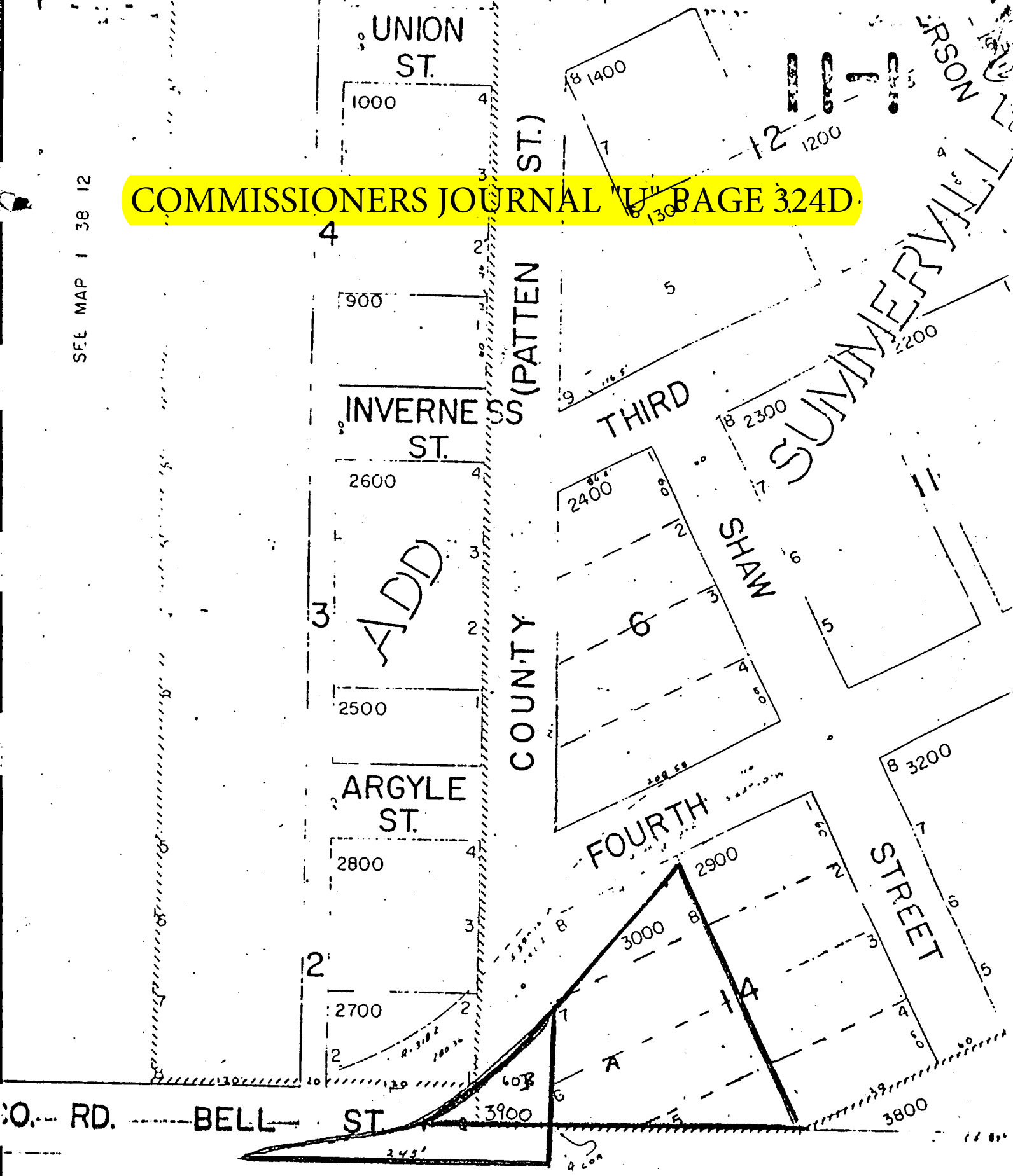

IN THE MATTER OF  
THE JAIL CLOSURE

COURT ORDER

IT APPEARING TO THE COURT that the Union County Jail does not meet the minimum jail standards as set forth in Oregon Revised Statutes; and

IT FURTHER APPEARING TO THE COURT that it is in the best interest of all concerned that the Union County Jail be closed for all long term prisoners and be used for only short term detention, not exceeding twenty-four(24) hours, excepting holiday, Saturdays, and Sundays, and upon Motion duly made by Harold Schwebke and seconded by Ralph Robinson, with three affirmative votes, it is hereby

ORDERED that the Union County Sheriff be instructed to hold persons in detention in the Union County Jail for periods not to exceed twenty-four(24) hours, excepting Saturdays, Sundays, and legal holidays.

IT IF FURTHERE ORDERED that the Union County Sheriff make arrangements with the Umatilla County and Malheur County or such other facilities are as available and appropriate for the detention of persons being held in custody for longer than twenty-four(24) hours.
