#### NARRATIVE

This survey was ordered by R. Neilie Bogue Hibbert in order to partition her tract of land into 2 parcels. I base the exterior of Block 34 and the placement of the railroad spur line on Minor Partition 1993-10.

Partition 1993-10.

Block 34 was not originally subdivided and the various tracts within it are described by metes and bounds descriptions. I place the southwest corner of this surveyed tract at record distance of 260.00 feet from the southwest corner of Block 34 as per deed volumes Book 128 Page 573 and Book 159 Page 670.

The south line of this surveyed tract runs at right angle to the west line of Block 34 and the record distance of 115.00 feet.

I then drive southerly parallel with the west line of Black 34 to the north line of the railroad spur line right of way. Since this surveyed tract is a remnant it will receive the excess area found along the west side of Block 34.
