

SURVEYOR'S NARRATIVE

THIS SURVEY WAS PERFORMED AT THE REQUEST OF LARRY STARR FOR THE PURPOSE OF FURTHER SUBDIVIDING PARCEL #3 OF MINOR LAND PARTITION PLAT 1997-17 OF THE UNION COUNTY RECORDS. THE DIVIDING LINE BETWEEN THE TWO NEW PARCELS IS THE CENTERLINE OF SPRING CREEK AS SHOWN HEREON. ALL OTHER BOUNDARY LOCATIONS ARE TAKEN FROM MINOR PARTITION PLAT 1997-17. THE REMAINDER PARCEL WAS NOT SURVEYED.

SURVEYOR'S CERTIFICATE

I, HARMON E. MCLENDON, DO HEREBY DEPOSE AND SAY THAT I HAVE CORRECTLY SHOWN AND MONUMENTED WITH PROPER' MONUMENTS THE LAND REPRESENTED ON THE ATTACHED PARTITION PLAT IN ACCORDANCE WITH THE PROVISIONS OF O.R.S. CHAPTER 92. SAID LAND BEING DESCRIBED AS FOLLOWS: PARCEL #3, OF MINOR PARTITION PLAT #1997-17 CITY OF SUMMERVILLE, UNION COUNTY, OREGON, MORE PARTICULARLY DESCRIBED AS FOLLOWS:
