

SECTION 15, T.1N., R.39E., W.M., ELGIN OREGON.





I, HARMON E. McLENDON, DO HEREBY CERTIFY AND SAY THAT I HAVE CORRECTLY SHOWN AND MONUMENTED WITH PROPER MONUMENTS THE LAND REPRESENTED ON THE ATTACHED PARTITION PLAT IN ACCORDANCE WITH THE PROVISIONS OF O.R.S. CHAPTER 92, SAID LAND SITUATED IN THE NORTHEAST ONE-QUARTER AND THE NORTHWEST ONE-QUARTER OF SECTION 22, AND THE SOUTHWEST AND SOUTHEAST ONE-QUARTERS OF SECTION 15, T.1.N., R.39E., W.M., BEING ALL OF PARCEL NUMBER 3 OF PARTITION PLAT 2005-0009 AS AMENDED BY A LOT LINE ADJUSTMENT SHOWN ON UNION COUNTY SURVEY 024-2006, MORE PARTICULARLY DESCRIBED AS FOLLOWS:


