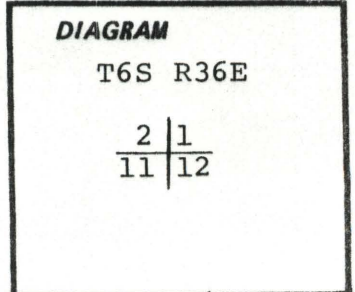


CERTIFIED RECORD OF LAND CORNER MONUMENTATION

Index File No. E-21

History of original corner establishment: Corner established in 1883 by William B. Barr under Contract No. 492.

A 14x12x12 stone was set, from which:  
a 48" Tamarack bears N50°E, 43 lks., and  
a 48" Tamarack bears S75°E, 9 lks.

Description of corner evidence found:

Found original stone, with notches, firmly in place.

Bearing trees found:

- A 58" W. Larch bears N50°E, 43 lks., open blaze, scribing visible: 6S R36E S1 (Tree in good condition).
- A 58" W. Larch bears S75°E, 19 lks (original notes say 9 lks.), open blaze, scribing visible: 6S R36E S12 B (Tree in good condition).

Found partially filled pits 5½ft. south and 5½ft. west.

Description of monument and accessories established to perpetuate the original location of this corner: Cap is stamped:

Set 2.5"x30" aluminum capped aluminum pipe rising 3" in mound of stones. Buried original stone on south side of cap. Set steel fence post 3 ft. north of corner.

- 20" D. Fir bears S80°W, 44.2 ft., blazed & scribed: T6S R36E S11 BT.
- 10" D. Fir bears N11°W, 19.1 ft., blazed & scribed: T6S R36E S2 BT.

Attached 3/4" brass washer marked LS 1848 to blazes. Painted blazes and attached signs as per Standard Specifications for Cadastral Surveys, USFS Region 6, March 1982.

To find corner, go from 5125, 0.2 mi. northeasterly on 5125374, to a 5" W. Fir on the right with a location poster. Follow old line logging skid trail S30°E, 400 ft. to corner. Corner is 50 ft. west of the creek on a southeasterly slope.
