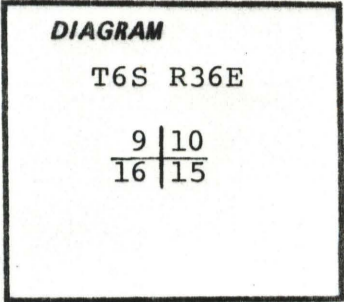


CERTIFIED RECORD OF LAND CORNER MONUMENTATION

History of original corner establishment: Corner established in 1883 by William B. Barr under Contract No. 492.



A pine post was set, from which:
a 12" Pine bears N20°E, 37 lks.,
an 8" Pine bears S50°E, 80 lks.,
a 10" Pine bears S50°W, 24 lks., and
an 8" Pine bears N55°W, 22 lks.

Description of corner evidence found:

No corner monument found.

Bearing trees found:

Decayed remains of L. Pine, diameter unknown, bears N20°E, 37 lks, scribing visible: BT.
An 8" L. Pine, dead & down, bears S50°E, 80 lks, open blaze, scribing visible: T6S R36E S15 BT.
A 10" L. Pine, dead & down, bears S50°W, 24 lks., open blaze, scribing visible: T6S R36E.

Description of monument and accessories established to perpetuate the original location of this corner:

Cap is stamped:

Set 2.5"x30" aluminum capped aluminum pipe rising 4" above ground. (No stones available.)
Set steel fence post 3 ft. north of corner.
