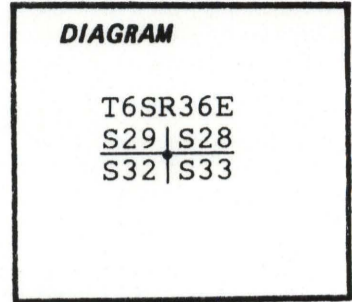


CERTIFIED RECORD OF LAND CORNER MONUMENTATION

Index File No. V-09

History of original corner establishment:

Original corner established in 1883 by William B. Barr under contract #492. Set a basalt stone 16"x14"x6", 11" in ground. From which:
A 6" Pine bears N25°E, 40 lks.
A 7" Pine bears S80°E, 17 lks.
A 54" Tamarack bears S30°W, 19 lks.
A 6" Pine bears N75°W, 20 lks.



Description of corner evidence found:

Found original stone, 16"x14"x6", with 1 groove on South and 4 grooves on East faces, firm in place and good position with the original bearing trees.
Found the following original bearing trees:
An 8½" dead standing Lodgepole Pine bears N25°E, 40 lks., open blaze full scribing visible.
An 8½" dead standing Lodgepole Pine bears S80°E, 17 lks., open blaze, full scribing visible.
A 37½" Western Larch (live, good condition) bears S30°W, 19 lks., blaze healed over, did not open.

Description of monument and accessories established to perpetuate the original location of this corner:

At the position of the original stone, I set a 2½"x30" aluminum capped aluminum pipe rising 7" in a mound of stones and placed orig. stone on North side in mound. I set a steel fence post 3' North of corner

New BT's:
A 5½" Spruce bears N49½°E, 26.9 ft., blazed&scribed: T6SR36ES28BT
A 6½" Spruce bears S54½°E, 20.4 ft., blazed&scribed: T6SR36ES33BT
A 5" Spruce bears N18½°W, 25.6 ft. blazed&scribed; T6SR36ES29BT

Painted blazes and attached signs as per Standard Specifications for Cadastral Surveys, USFS Region 6, March 1982. A ¼" brass disk stamped "RLS 1848" was nailed to the lower end of the blazes.

Go to South end of Rd. 5135, corner is N70°W, 1200 feet on Southwesterly slope 600 ft. North of a creek that flows Northwest.
