NARRATIVE

This map revises Survey No. 60-80 as filed with the Union County Surveyor. It was brought to our attention in Survey No. 51-81 that we had incorrectly located the intersection of Spring Ave. and Seventh Street at Washington Avenue. Upon review, we concur in the configuration as shown on said Survey 51-81.

Our field location now agrees with the location shown at the SE corner of the parcel surveyed on Survey 51-81. Our previous monuments at the NE and NW corners were destroyed by construction, we established new monuments as shown.

Two badly bent iron rods were found standing together, extending approximately one foot above the gravelled alley surface and approximately one foot south of the correct survey position, the plastic caps are missing. It appears that these monuments were disturbed and then replaced in their approximate original positions by unknown parties. We establish a new monument at the correct survey location and removed both damaged monuments.
