

NARRATIVE

This survey was ordered by Terry Huffman. I located the Southwest corner of Section 20 and the 3/4" pin at Esther Avenue and Hunt Lane and projected the South 1/4 corner into position, as the 1/4 corner was under the highway paving. I place the West 1/16 between Sections 20 and 29 by standard proportion. The Center West 1/16 was set by the county surveyor S. B. Morgan in June of 1955. The center of Section 20 is now under confusion. The center of section was a bolt at the intersection of Ruckman Avenue and Dry Creek Road, and has been used as the center of section for a number of years. I therefore use the bolt in this survey for the center of section because of its history and its relativity to the monument set by survey number 41-79. In my opinion the bolt is more acceptable than using the average bearing of the centerlines of Esther Avenue and Lone Pine Avenue as used in survey no. 41-79, plus you have history of a known monument.

I find that Amalgamated Sugar Company owned the West half of the Southeast quarter of the Southwest quarter of Section 20. They sold parcels off one by one with all of the parcel descriptions beginning at the Southwest corner of the Southeast quarter of the Southwest quarter running North in multiples of 20 rods and East 40 rods. The West line of the Amalgamated property is long by some 24 feet as shown. I have placed all of the excess North of Huffman into the County Road because of the deed progressions. There can be no proportion of the excess because of the manner in which the deeds are written. I find that survey number 97-74 did not survey to the title lines and the property occupied by the school is 14 feet too far North. Mr. Huffman has indicated that he wants to boundary agree to the North line of survey number 97-74 and I have set the Southerly pins on this basis.
